

HIGHWAY DISTRICTS

At a meeting of the Commissioners of Highways holden on this 12th day of March 1844 for the purpose of dividing the Town of Beloit into road districts. It is determined to district the town as follows:

- District No. 1 - Shall contain all the Village of Beloit which lies South of the center of Broad Street and East of the center of Turtle Street and all the lands in Sections 36 of Town 1 Range 12 not included of the Village of Beloit except on the North side of the village. Sections 31, 32, 33 in Township 1 of Range 13.
- District No. 2 - Shall contain that part of the village of Beloit lying between the center of Broad Street and the center of School Street and Sections 17, 20, 21, 28, 29 and the East half and the Southwest quarter of Section 30 in Town 1 of Range 13.
- District No. 3 - Shall contain 28, 29, 30, 31, 32 & 33 in town ship No. 2 of Range 13 and Sections 4, 5, 6, 7, 8, 9, 17, 18, 19 and Northwest quarter of 30 in Township 1 of Range 13.
- District No. 4 - Shall contain all the Village of Beloit lying North of the center of School Street and all the land in Section 36 of Township 1 of Range 12 lying North of the village and all that part of Township 1 of Range 12 lying East of Rock River and North of Section 36.
- District No. 5 - Shall contain all the Village of Beloit lying West of the center of Turtle Street and all Sections 1, 2, 3, 4, 9, 10, 11, 14, 15, 23, 26, 35 lying West of Rock River.
- District No. 6 - Shall contain Sections 19, 20, 21, 22, 27, 28, 29, 30, 31, 32, 33 & 34 in Township 1 of Range 12 and sections 24, 25, 36 in Township No. 1 of Range 11.
- District No. 7 - Shall contain Sections 5, 6, 7, 8, 17 & 18 in Township No. 1 of Range 12 and Sections 1, 12 & 13, in township 1 of Range 11.

District No. 8 - Shall contain Sections 14, 15, 17, 18, 19, 20, 21, 22, 23, 26, 27, 29, 30, 31, 32, 33, 34 & 35 in Township 1 of Range 11 and Sections 13, 14, 15, 17, 18, 19, 21, 21, 22, 23, 24, 25, 26, 27, 28, 30, 31, 32, 33, 34, 35 & 36 in Township 1 of Range 10.

District No. 9 - Shall contain Sections 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, in Township 1 of Range 11 and Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 7, 8, 9, 10, 11 & 12 in Township 1 of Range 10.

LAWS OF THE WISCONSIN TERRITORY

An Act to organize certain towns therein named.

Be it enacted by the Council and House of Representatives of the Territory of Wisconsin.

That all that part of Beloit in the County of Rock comprised in Sections 10, 15, 22, 27, and 34 in Town 1 North of Range 13 E. be annexed to and form a part of the Town of Clinton.

Approved March 21, 1843
