

RELEASE OF HIGHWAY

Whereas by an order bearing date the 3rd day of June 1876 the supervisors of the Towns of Beloit and Newark in Rock County laid out a highway described as follows: Commencing at the N.E. corner of Section 12 in the Town of Newark and the N.W. corner of Section 7 in the Town of Beloit; and running thence due South on the town line. The center line of said highway to commence at a point on the Madison and Beloit road 39 rods South of the Southwest corner of Section 6, Town 1, Range 12 East running thence Due North 39 rods on the town line between Newark and Beloit to the Southwest corner of Section 6 Town 1, Range 12 until it intersects the Beloit and Madison Road there to terminate of distance running 39 rods which passes through the following described lands owned by me viz: N.W. 1/4 of the N.W. 1/4 of Section 7 in the Town of Beloit, County of Rock. State of Wisconsin.

Now, know all men by these presents that, I, Taurus Saberson for value received hereby release all claim to damages sustained by me by reason of the laying out and opening said highway through my said lands.

To the Supervisors of the Town of Beloit
Rock County, Wisconsin

We the undersigned freeholders residing in said town do hereby make application to you to lay out a highway in said town as follows: Commencing at a point in the Beloit and Janesville River Road on the East side of Rock River where the quarter section line crosses said road - thence running East on said quarter line to quarter stake on the post between Section 23 and 24; thence East on the quarter section line through section 24 to the town line road leading from Beloit to Janesville.

It being known to the undersigned that a road was laid out and half of land for same was taken off of the North side of land herein described, to the extent in width of two rods from the East to the West line of same --- and that the owner and occupants of the land herein referred to on the line aforesaid have neglected and refused to open same --- for said road.

Reference to record of the laying out of said road is herein made, recorded May 30, 1854.
