#### **Background**

The Fox Lake Subdivision begins at Milepost 49.5 in Fox Lake, IL and ends at Milepost 98.5 in Janesville, WI, traversing the Wisconsin and Illinois portions of the WRRTC owned-system in Rock, Walworth and McHenry Counties. This event will begin in Janesville where all will board a motorcoach for Fox Lake, IL. At Fox Lake, all will board the train for an excursion back to Janesville. The excursion will highlight past, current and upcoming rehabilitation projects including bridge projects in Illinois and WSOR's upcoming CWR project between Walworth and the State Line.

**Safety:** Guests may be on an active railway and around rail equipment. We advise wearing jeans and work boots. If a guest does not have boots please wear comfortable shoes. No open-toe shoes or heels. Eye and ear protection will be provided if needed.

**Transportation:** Please arrive at WSOR's Janesville Roundhouse, 203 S. Pearl Street, Janesville, WI by 12 Noon.
