Improving the Health of Rock County

This report is a summary of the Community Health Assessment (CHA) that shows the current health of Rock County. The CHA was created by the Health Equity Alliance of Rock County (HEAR). HEAR is a group of over 100 people from different parts of the community who work together to help make Rock County healthier. The full CHA can be used as a guide for showing how certain things, like health inequities, affect the health of some people more than others.

Key Findings:

- **Mental Health and Access to Care are the top focus areas for the Community Health Improvement Plan**
- **Rock County residents report that their communities are a good place to raise a family with good schools and access to parks and recreation**
- **Many of Rock County's health problems are caused by health inequities**
- **Rock County residents have concerns with access to affordable basic needs (housing, transportation, healthy foods, etc.)**

Emphasis on Health Equity

Many of the health differences we see in Rock County are caused by inequities, or avoidable differences in health that are widespread. Health inequities affect many groups of people. HEAR understands that to improve the health of Rock County, we must work on improving health equity. Health equity is the opportunity for everyone to live a healthy life. The full CHA report has "Health Equity Spotlights" that highlight real examples of inequities in Rock County.

Rock County's Top Health Priorities

Using the CHA and community feedback, HEAR found six health priorities for Rock County. The health priorities are Mental Health, Access to Care, Substance Use, Built Environment, Economic Stability, and Chronic Disease. HEAR will focus on Mental Health and Access to Care in future projects, but we encourage community partners to work on each health priority to improve the health of Rock County.



Leading Causes of Death in Rock County, 2017-2020




Moving Forward
