We the undersigned supervisors of the Town of Johnstown in the County of Rock having by an order bearing date October 30th, 1869 upon due application for that purpose laid out a highway as follows: Commencing at a point in the center of the Big Foot and Madison Road opposite the residence of John Miles on Section 21 and running East 20 rods; thence in a Northeasterly direction until it intersects the 80 rods line 80 rods West of Section line dividing Section 21 and 22; thence North along said line until it intersects the Stone School House road running East and West on Section 9 in said town of Johnstown and the following named owners of lands through which said highway is laid not having released all claim to damages sustained by reason of the laying out and opening of said highway and we not being able to agree with them as to the amount of such damages having applied to them for that purpose and endeavored to make such agreement did at this date assess the damages which such owners will sustain by reason of the laying out and opening of such highway through their lands as follows to wit:

To G. and R. Page on Section 21 T. 3 N., R. 14 being so much of the East $\frac{1}{4}$, South half, N.E. $\frac{1}{4}$ and also part of S.E. $\frac{1}{4}$ of same section as lies on the East side of said described highway; we have assessed and hereby award the sum of \$5 as such damages. To H. B. Johnson on Section 21 T. 3 N., R. 12 being so much of the East $\frac{1}{4}$ South half, N.E. $\frac{1}{4}$ and also part of S.E. $\frac{1}{4}$ of same section as lies on the West side of the above described highway also the N.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Section 21 and South $\frac{1}{4}$, North half, S.E. $\frac{1}{4}$, Section 16, T. 3 N., R. 14 also East half, S.E. $\frac{1}{4}$ Section 16, T. 3 N., R. 14, we have assessed and hereby award the sum of five dollars as such damages. To Ellen Moore on N.E. $\frac{1}{4}$, N.E. $\frac{1}{4}$, Section 21, T. 3 R. 14 we have assessed and hereby award the sum of \$6. To Thebron Wadsworth on S.E. $\frac{1}{4}$, N.E. $\frac{1}{4}$ and North half, N.E. $\frac{1}{4}$, S.E. $\frac{1}{4}$ Section 16, T. 3 N., R. 14 we have assessed and hereby award the sum of \$1. To James McKinnon on West half, N.E. $\frac{1}{4}$, N.E. $\frac{1}{4}$, Section 16, T. 3 N., R. 14 we have assessed and hereby award the sum of \$5. To Peter Van Nostrand on the East half, N.E. $\frac{1}{4}$ Section 9, T. 3 N., R. 14 we have assessed and hereby award the sum of \$110. To W. H. Newton on West half, N.E. $\frac{1}{4}$ Section 9, T. 3 N., R. 14 East we have assessed and hereby award the sum of \$125. as such damages.
