

Survey of a part of the road running on the section line between sections 8^{and 9}, 16^{and 17}, 20 & 21^{and 22}, 28^{and 29}, 32^{and 33}. RICEY ROAD

Beginning at the $\frac{1}{4}$ Post on the section line between section 20 & 21; thence North on said line 27.93 chains to the center of the Road running Easterly and Westerly across section 20 & 21 T. 4 R. 11 and the length of road hereby taken up is 27.93 chains.

Survey of a Road in the town of Porter made May 10th 1851. CALLEDONTA

Beginning at a point two rods South of the $\frac{1}{4}$ post on the East line of Section 13, T. 4. N. of R. 11 E.; thence West parallel with the $\frac{1}{4}$ line running through said section 276.96 rods; thence N. 11° W. 13.00 chains; thence N. 88° W. 11.48 chains to the East end of Raymonds Mill dam; thence commencing at the West end of said Dam S. 7 $\frac{3}{4}$ ° E. 11 chains to a point on said $\frac{1}{4}$ line 4.90 chains west of the $\frac{1}{4}$ Post on the East line of Section 14.5; thence West on said $\frac{1}{4}$ line and the $\frac{1}{4}$ line of Section 15, 135.10 chains to the N.E. Corner of the S.W. eighty of Section 15, T. 4. R. 11 and the whole length of the Road is three miles and six links.

Survey of a road in the town of Porter made Dec. 10th A.D. 1853 WILDER ROAD
Beginning at a point on the highway leading westerly from John R. Boyces across sections 22, 21, 20 & 19 where the North & South center line of Section 20 intersects the same; thence North on the center line of Sec. 20, 8.20 chains to the $\frac{1}{4}$ Post on the North line of Section 20; thence North on the center lines of Sections 17.8^{and 5} to the $\frac{1}{4}$ Post of the North line of Section 5 T. 4 N. of R. 11 E. and the whole length of the road is 3 miles 8.20 chains. Courses given according to the true meridian.
