Page 17 of Record

Whereas upon the application of six freeholders residing in said town of Porter for the laying out of a highway hereinafter described we the undersigned supervisors of said town and the Supervisors of the town of Dunkirk in the County of Dane, did on the 6th day of January 1860 meet at the house of Wm. K. Clark in the said town of Porter for the purpose of then and there deciding upon such application it being the time and place fixed by us for that purpose did proceed to examine personally such highway and having then and there heard such reasons as were offered for and against laying out the same, did then and there decide upon such application, and determine to lay out said highway as hereinafter described; having as required by law, first made out a notice and fixed therein a time and place at which we would meet and decide upon such application and the applicants for such highway having five days previous to our meeting caused such notice to be duly given to all the occupants of the lands through which said highway passes and such notice having also been posted up in three public places in said town ten days before the time of our said meeting; it is ordered and determined, and we do hereby order and determine, that a highway be and the same is hereby laid out pursuant to said application; whereof an accurate survey has been made which is as follows to wit: commencing on the county line between the above named towns, at a point 22.33 chains East of the quarter post on the South line of Section 34 T. 5 Range 11 East; thence W. on County line 142.33 chains to the S.E. corner of Sec. 32 R. 5 R. 11 East courses given according to the true meridian; variation of the needle 8° degrees and that the said line above described be the center of said highway and the same is established, 4 rods wide and it is further ordered that the said highway be divided into two road districts as follows the East part to the South East corner of Section 33 T. 5 R. 11 East, shall be one road district and shall be allotted to the town of Porter and the residue to be the other road district and be allotted to the town of Dunkirk.
