We the Commissioners of Highways for the Town of Turtle, Rock County, Wisconsin Territory, met at the house of Daniel M. Tallman of said town on Tuesday the 25th day of January, 1848 at ten o'clock A.M. for the purpose of examining the ground on the line petitioned to be laid out as a highway by D. M. Tallman and nine others, freeholders of said town, and we hereby certify that upon being satisfied that notice of the time and place and purpose of this meeting had been given as the law requires, we proceeded to examine the line on the ground petitioned for and that we have caused a survey and description to be made which is as follows to wit:

Beginning at the intersection of the Wyman Road with the line between Town 1 and 2 North; thence bearing South 64%° West, 6 chains and 60 links to the line between 1 and 2, Town 1 North, Range 13 East, Wisconsin Territory, at a point three chains and I link South of the corners of Sections 1, 2, 35 and 36; thence South 53%° West 25 chains; thence South 55° West 23 chains to a point 60 links East of Spring Brook; thence 66% West 44 chains and 20 links to line between Section 2 and 3; thence same course 23 chains and 40 links to road leading by school house; thence same course 20 chains and 42 links to North and South center line of Section 3. 38 links North f1/2º East of a Burr Oak tree; thence same course 43 chains to line between Sections 9 and 10 at a point 86 links South of the corners of Section 3, 4, 9 and 10; thence same course 49 chains and 10 links to road over Turtle Creek Bridge, at Turtleville; thence same course 10 chains and 90 links to a point bearing North 6° West 77 links to a pointNorthwest corner of John Lenis, framed house; thence South 82% West 33 chains to a stake near the West side of Crop Grove; thence South 31/2° West 9 links from Black Oak tree; thence South 34%° West 60 chains and 30 links to line between Sections 8 and 17; thence same course 47 chains and 38 links to East and West center line of Section 17; thence South 12%° West 16 chains and 44 links to stake Westward of Gordon's house; thence South 534° West 16 chains and 29 links to a stake 50 links South side of Turtle Creek; thence South 19%° West 14 chains to a stake bearing North 50° East 50 links from South end of Dole's sod fence; thence South 36%° West 49 chains and 25 links to line between Tuttle's and Reed; thence South 46% West 60 chains to line between Range 12 and 13, 10 rods South of the Northwest corner of Section 30
