Itinerary

Depart Land Conservation Department @ 9:15 am.

1. **Arrive at 9:25 am. Delavan Drive Properties LCC**, Section 6, LaPrairie Township. Active non-metallic mine reclamation project. Discussion relating to the program in general and a brief history of the property which ultimately lead to reclamation of the site. Details of this stop are dependent on the progress of the work scheduled to being in the weeks prior to the tour. **Depart at 10:00 am.**
2. **Arrive at 10:20 am. Frito Lay Property**, City of Beloit. Observe grassed water way and stream crossing conservation practices installed on agricultural lands within a developing area of City of Beloit along Spring Brook. **Depart at 10:45 am.**
3. **Arrive at 11:00 am. Dave Moyer Property**, Section 29, Bradford Township. Observe wildlife scrapes installed near Turtle Creek. **Depart at 11:10 am.**
4. **Arrive at 11:15 am. Gavilon Grain, LLC**, Section 17, Bradford Township. Grain Elevator expansion/reconstruction project requiring planning, permitting and installation of erosion control and storm water management facilities. **Depart at 11:45 am.**
5. **12:00 pm. Lunch Stop. Prairie Woods Golf Course**, Johnstown Township. **Depart at 1:00 pm.**
6. **Arrive at 1:10 pm. Rock Prairie Dairy**, Section 2, Bradford Township. View large dairy operation which was under construction during the 2011 Conservation Tour. Main focus will be the manure handling system and storm water management features permitted by LCD. **Depart at 2:25 pm.**
7. **Arrive at 2:35 pm. Emerald Heights Farm**, Section 8, Bradford Township. View various conservation practices including terrace and grassed waterway system and discuss, in general, farm compliance elements of the state Farmland Preservation Program. **Depart at 3:00 pm.**

Return to the Land Conservation Department @ 3:15 pm.
