Authority to Initiate

- III-F. Every Supervisor shall have the prerogative to introduce a resolution on any matter.
- III-I. Resolutions may be initiated or drafted by residents of Rock County. No resolution, initiated and/ or drafted by a county resident, shall be considered by the Rock County Board unless it deals with the business and concerns of the County and is properly submitted by a County Board Supervisor.

Ordinances

III-H. Ordinances or Ordinance amendments presented to the County Board, after consideration by the appropriate governing committee or committees, shall not be acted upon by the County Board until there has been a first reading, a second reading, and a Public hearing by the County Board. Readings shall be by title at successive meetings of the County Board, and complete texts shall be available for public examination in the Office of the County Clerk between the first and second readings. The Public Hearing by the County Board shall be at the same meeting as and immediately following the first reading. Public notice of the first reading, the public hearing, and the second reading shall be by inclusion on the respective County Board agendas

"Whereas" Clauses

Whereas clauses are intended to make the case for the need for the action identified in the Resolved clauses

Adoption of the 2020-2025 Rock County Parks, Outdoor Recreation and Open Space (POROS) Plan

- WHEREAS, it is good management practice for the Rock County Parks Division to have a longrange plan to assure that park planning goals, objectives, and policies are current for its operation and assets; and,

WHEREAS, the Wisconsin Department of Natural Resources requires that the County update its POROS Plan every five years to maintain such eligibility and to assure that park planning goals, objects, and policies are current; and

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly
assembled this _____ day of _____, 2020, hereby adopts the 2020-2025 Rock County Parks,
Outdoor Recreation, and Open Space (POROS) Plan, to serve as the County's updated POROS
plan and chapter twelve of the Rock County Comprehensive Plan 2035.

Executive Summary

- Typically will be very similar to Whereas clauses
- In more narrative "plain language" format
- Includes more detailed information
- Drafted by County staff or County Board member

In order to remain eligible for state, federal and foundation grants, Rock County needs to update the 2015-2020 POROS Plan. These grant funds, along with local matching funds can continue to be utilized to help improve the county's parks, outdoor recreation facilities, and open space areas to the benefit of Rock County citizens quality of life. The Plan has a five-year planning horizon. It will need to be updated in 2025 for the next five-year planning period.

The POROS planning process included a data gathering process that used extensive public participation including staff input sessions, community survey, focus groups, and an open house.

The proposed Rock County POROS Plan is one document and includes the following sections: 1) Introduction and Background Information, 2) Planning Process and Public Participation, 3) Existing Park and Recreational Facilities, 4) Goals, Objectives, and Policies, 5) Park and Recreation Standards, 6) Analysis of Existing Park and Recreation Facilities, 7) Recommended Park and Open Space Improvements, 8) Capital Improvements Plan, and 9) Implementation Action Plan.

Preparation and Notes

III-E. It shall be the responsibility of the sponsoring committee, official, or citizen to have the matter prepared in the form to be acted on and to have the attached legal note prepared by the Corporation Counsel, fiscal note prepared by the Finance Director, and the administrative note prepared by the Administrator. The Chair may add a note. If in reviewing the fiscal or legal notes, the Administrator disagrees, the Administrator shall so state in the Administrative Note. The required notes must be attached before the governing committee may take action.

Notes Attached to Resolutions

- Legal Note
 - Typically provides statutory citation for authority to take action
 - May include guidance on relevant legal issues
- Fiscal Note
 - Typically includes source of funding and whether expense was budgeted
 - May indicate no fiscal or indeterminate fiscal impact
- Administrative Note
 - Typically "Recommended" or "Matter of Policy"
 - May provide additional information for consideration not already in resolution
- Board Chair's Note

Process County Board Rules of Procedure

III-B. The format for the Agenda shall be as follows:

10. Introduction of New Resolutions or Ordinances by Supervisors for Referral to Appropriate Committee

Referral

III-F. Every resolution introduced shall be referred to the appropriate committee by the Chair of the Board within 20 calendar days. If the governing committee does not report a resolution within 60 days from the time it was referred to the committee, five supervisors may bring the resolution to the Board floor.

Outcome of Committee Actions

IV.-D. Upon a committee's recommendation to approve or adopt a matter, the matter shall be placed on the next regular Board Meeting agenda that is practicable. If a committee's recommendation is against approval or adoption of a matter, then the matter may be placed before the County Board at the discretion of the Chair.

Bringing a Resolution to the Floor if no Committee Action

III.-F. Every resolution introduced shall be referred to the appropriate committee by the Chair of the Board within 20 calendar days. If the governing committee does not report a resolution within 60 days from the time it was referred to the committee, five supervisors may bring the resolution to the Board floor.

- This is typically done by invoking section III.-F., collecting five signatures, and presenting the document to the County Clerk.
 - (e.g., "Per Rock County Board of Supervisors Rule III.-F., the undersigned Supervisors do hereby request that the resolution ______ be placed on the agenda at the County Board's next meeting.")
