## EDUCATION, VETERANS AND AGING SERVICES COMMITTEE Minutes – January 19, 2021

<u>Call to Order</u>. Supervisor Peer called the meeting of the Education, Veterans and Aging Services Committee to order at 4:34 P.M. on Tuesday, January 19, 2021 via teleconference.

**Committee Members Present**: Supervisors Pam Bostwick, Taylor and Peer.

**Committee Members Absent:** Supervisors Rashkin and Wilde.

**Approval of Agenda.** Supervisor Pam Bostwick moved approval of the agenda as presented, second by Supervisor Taylor. ADOPTED.

#### **Council on Aging**

Report of Growth of Nutrition Program and Discussion on Need for Second Full Time Staff. Ms. Schutt introduced Linda Hardie, Nutrition Program Supervisor. Ms. Hardie shared the requirements for participants in the meal program. She also shared her job requirements with the committee. They currently have 627 clients which all need initial assessments and an annual assessment. The over the phone initial assessment takes approximately 30 to 45 minutes while the annual assessment takes approximately 15 to 20 minutes. They have worked with the same amount of staffing from 2014 to current which is one full time employee, Ms. Hardie, and a .4 part time employee. During that timeframe, there has been an increase of 25,743 meals.

Ms. Schutt said she does have some funds that will carryover in to 2021 because of federal funding that was provided in 2020. The committee members told Ms. Schutt they

would support a resolution to add a second full time staff member for the nutrition program. They would like to see this move through the approval process before the next scheduled EVAS meeting. The committee agreed to meet either on Tuesday, February 2<sup>nd</sup> or February 9<sup>th</sup> at 4:30 P.M. to approve the resolution so that it can be put on the first County Board Staff agenda and County Board agenda in February. Ms. Schutt will get started preparing the resolution.

**2022** Aging Plan and Title VI Plan (as it applies to integration). Ms. Schutt said she will be meeting with Kate Luster and Josh Smith on preparing the 2022-2025 Aging Plan as it applies to integration along with the Title VI plan.

**Semi-Annual Reports.** The committee accepted the reports.

**Committee Requests and Motions.** Discussion above.

<u>Adjournment.</u> Supervisor Pam Bostwick moved adjournment at 5:22 P.M., second by Supervisor Taylor. ADOPTED.

# Creating a 1.0 FTE Nutrition Program Assistant for the Council on Aging Nutrition Program and Amending the 2021 Council on Aging Budget

WHEREAS, the Rock County Council on Aging operates a Senior Nutrition Program Monday through Friday to provide hot meals to Rock County residents over 60; and

WHEREAS, the Council on Aging Nutrition Program has operated with 1.4 FTE since 2014; and

**WHEREAS,** since 2014 there has been more than a 300% increase in home delivered meals ordered through the program; and

**WHEREAS,** this increase is accredited in large part to population growth of residents age 60 and over in Rock County; and

WHEREAS, it has become increasingly difficult for staff to effectively complete all the necessary tasks that keep the program running smoothly; and

WHEREAS, in CY 2020 the Nutrition Program received \$371,588 in COVID Relief Funding; and

WHEREAS, instructions were received to spend down the COVID funding before traditional funding was spent; and

WHEREAS, this has left a carryover of approximately \$350,000 for CY 2021; and

WHEREAS, the Council on Aging Director is requesting the addition of a 1.0 FTE Nutrition Program
Assistant for the Nutrition Program. The new positions would be placed in Range 7 on the unilateral pay
grid with a pay range of \$37,270 – \$45,414.

**NOW, THEREFORE, BE IT RESOLVED** that the Rock County Board of Supervisors duly assembled this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2021 does hereby authorize creation of a 1.0 FTE Nutrition Program Assistant within the Council on Aging.

#### **Executive Summary**

The Rock County Council on Aging operates a Senior Nutrition Program, serving Rock County residents age 60 and over. Since 2014, the program has functioned with one 1.0 staff and one .4 staff. The senior population in Rock County is growing rapidly. Census charts indicate that between 2020 and 2025, residents age 60 and over will increase by just over 10,000. Between 2025 and 2030 they will increase another 8,200.

According to census statistics, the 60+ age group will remain from 25.1-30% of the population as a whole, although the actual number rises each year. There are 17,205 total households with one or more persons age 65+.

Since 2014, the number of meals served by the Rock County Nutrition Program has increased by over 300%. With this increase and the effects of the COVID pandemic, it has become increasingly difficult for staff to do all that is required to operate the Nutrition Program and stay in compliance with all the regulations required by the Older Americans Act.

In CY2020, The Nutrition Program received additional funding in the amount of \$371,588 as a result of Covid Relief Funding. Government stipulations required that the excess funding be spent down before the regular funding. This has left a carryover of approximately \$350,000 for CY2021. It is highly possible that carryover funding will be allowed for CY 2022 as well.

To effectively operate the Nutrition Program, The Council on Aging Director is requesting the addition of new position for the Nutrition Program. The new position would be placed in Range 7 on the unilateral pay grid with a pay range of \$37,270 – \$45,414. The title would be Nutrition Program Assistant.
