

Behavioral Health Redesign Steering Committee (BHRSC)

October 16, 2014

Call to Order. Chair Flanagan called the meeting of the Behavioral Health Redesign Steering Committee to order at 12:02 P.M. in Rooms N1-N2, Fifth Floor, Rock County Courthouse-East.

Approval of the Agenda. Supervisor Grahn moved approval of the agenda, second by Pastor Jackson. ADOPTED.

Approval of the Minutes of September 18, 2014. Mr. DeSloover moved approval of the minutes as presented, second by Mr. Perry. ADOPTED.

Workgroup Updates.

Data Workgroup: Chair Flanagan said this group's work is in line with the jail reentry project. She said an intern will work on the high utilizer study and there will be a data report from the reentry project at the next BHRSC meeting.

AODA Workgroup: Chair Flanagan said there is nothing new to report, as this group meets next week.

CCRG: Chair Flanagan said this group has not met since the last BHRSC meeting. She did hand out the data requested last time about the number of emergency detentions in Rock County.

Cultural Competency: Mr. Deupree said there is no report from this group.

Kids Continuum of Care: Mr. Horozewski said this group continues to meet. He said schools, community providers, etc. are struggling with caring for kids with mental health needs. He said there needs to be a residential crisis stabilization unit for kids in Rock County. Ms. Flanagan said they received a grant for trauma focused EBT and there will be a training for 30 community clinicians at no charge.

Adult Continuum of Care: Chair Flanagan said they are gathering data from community providers.

Consumer/Family: Chair Flanagan said this continues to be a positive process. Ms. Garrett said they decided on a project at the last meeting. Chair Flanagan said there will be a Peer Specialist Training in December and handed out information about the program.

Update on Justice and Mental Health Collaboration Grant Activities and Fill-out JMHCP Planning and Implementation Guide. Chair Flanagan led the group through some of the questions required under the JMHCP Planning and Implementation Guide. The results were as follows:

Short term goals:

- Identification of mentally ill individuals
- Manage linkage with treatment and services
- Follow-Up
- Providing support, such as education, housing, support networks, employment, benefits

Long term goals:

- Reduced recidivism
- Connection with permanent services
- Decreased functional impairment and improved quality of life
- Sustainability
- Decreased hospitalizations
- Decreased contact with law enforcement
- Increase mental health knowledge/competence amongst jail staff
- Family integration
- Improved data collection to show outcomes, gaps, etc.
- Cost savings
- Decreased isolation and increased social opportunities ("a place to go")

Mission Statement:

Our mission is to reduce recidivism, improve quality of life, and promote hope for people identified with behavioral health needs by linkage to comprehensive treatment and support.

There was further discussion about how to educate the public about the JMHCP project. Press releases, newspaper articles, radio interviews, report to the County Board and CJCC, were discussed.

Chair Flanagan said this would be on next month's agenda.

Time and Date for Future Meetings. Thursday, November 20, 2014, at Noon, in N1-N2, 5th Floor Courthouse East.

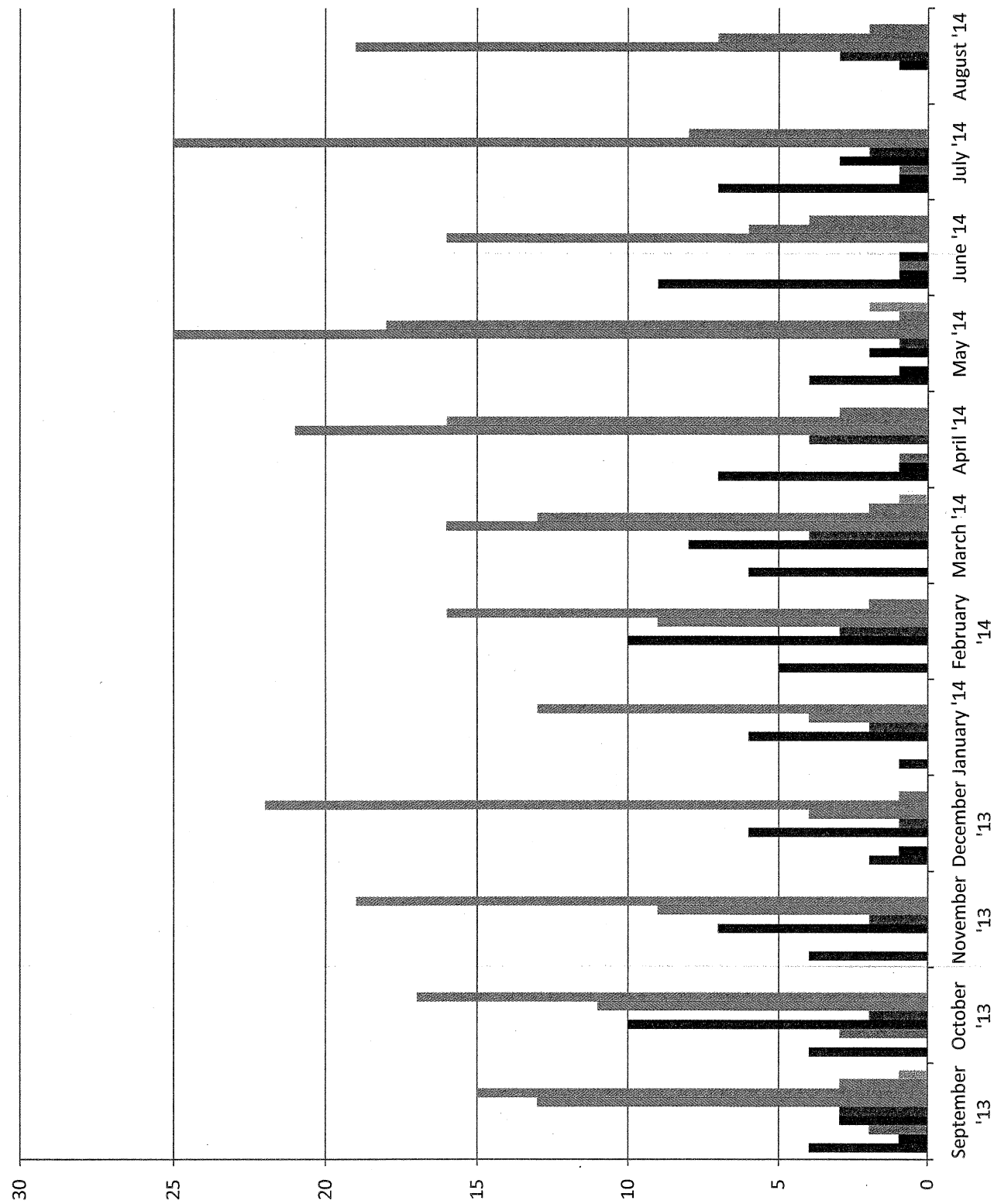
Adjournment. The meeting adjourned at 1:06 p.m. by acclamation.

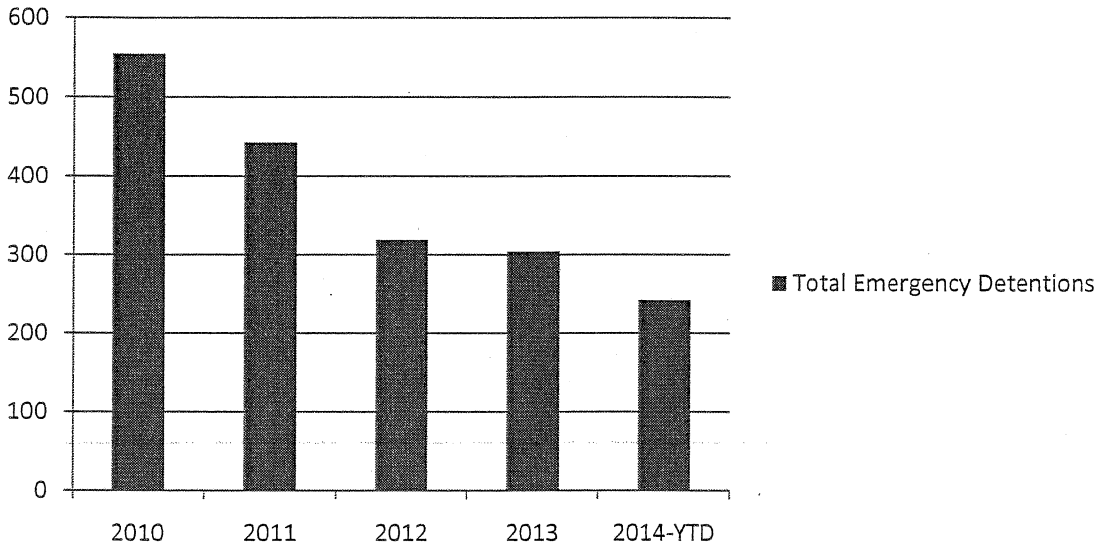

Figure 1: Monthly precipitation (mm) for the period from September 2013 to August 2014. The chart compares observed precipitation (black bars) with a model simulation (gray bars). The y-axis represents precipitation in millimeters, ranging from 0 to 30. The x-axis lists the months from September '13 to August '14. The model simulation generally overestimates precipitation in the winter months (October to February) and underestimates it in the summer months (June and July).

Description: This will be a dynamic training, utilizing the expertise of 2 current peer specialists working at ILR. It will be interactive, with activities, presentations, role playing, and sharing. The purpose of the training is to learn the skills to be a Peer Support Specialist. The curriculum was developed by the National Association of Peer Specialists (NAPS), but we will be adding local and regional resources too. Be prepared to move around, have fun, grow, and give. After successful completion of the training, you will be eligible to take the state certification test to become a Certified Peer Specialist in the state of Wisconsin.

Expectations: There will be an expectation to participate! There will be reading outside of class and an evaluation at the end of the training. Our approach will be relaxed; we aim to have fun and show that recovery really happens.
