Call to Order

Welcome and What's Going Well

Tina Day shared that Jerome has gotten his second job and he will be starting school in September and he is doing well.

Lance Horozewski shared that the first All CYF Staff meeting went very well. They watched a short documentary called "Healing Neen" about a women and the trajectory of trauma she went through until someone finally asked her "what happened."

Rebecca Westrick shared that the Grassroots organization is working on a mission statement.

RCHSD Re-Organization Update

The CYF Division is continuing with the Organizational Effectiveness project, which is the integration of JJ and CPS. They currently have a draft mission statement and core values—we will bring the final version to the meeting next month. They are working on developing a shadowing program within the division that would have workers shadow different functions within the division. This will allow workers to better understand their co-workers job functions. With the use of personal cell phones and personal computers for work we are struggling with the use of technology and boundaries and confidentiality issues.

Community Agency Updates

Jennifer Oas shared that Becky Hayd is the PATHS Coordinator. PATHS is for youth 17-21 who are currently in or previously have been in Foster Care.

Heather Helgestad shared that clinical service for children's mental health is currently hiring two new positions. CLTS is also hiring two additional positions.

Sarah Johnson shared that the Rock County Prevention workgroup has been working on collecting data through their strategic planning process and they are hoping to move into the planning process shortly.

CST Outreach Workgroup

Julie Fuelleman gave an update on the MOU. Lance, Rebecca and Julie met yesterday to discuss the best way to get MOU signatures. They would like to ask for volunteers to take the MOU to community agencies and get a verbal intent to sign and report back at the September meeting. After we get verbal intents we will work on taking one original document around to everyone for signatures by the October meeting.

Update on Parent/Youth Peer Support Development

Possible assistance with Service Payments

The group did some brainstorming to try to come up with ways to help clients who have large co-pays. There was a discussion about finding ways to help clients feel more comfortable with filling out hardship paperwork. It was decided to put together a workgroup to collect data on the possible benefits for people filling out the paperwork. Once data has been collected we will create a brochure on the procedure and possible results to help clients feel more comfortable. Julie Butz and Heather Helgestad will work on this and report back to the committee next month.
