Boys and Girls Club presentation

Jenny Sliker gave an overview of the programs offered by the Boys & Girls Club. Currently, the B&G Club serves 80-100 kids every day, Monday-Friday. During the school year they are open M-F, from 3-7 p.m. There is a one-time \$20 membership fee for the school year. For sites that provide transportation there is an additional \$20 per month fee. They offer scholarships and payment arrangements for families in need. The club is open to youth ages 6-18. The B&G Club has a summer day camp program that runs from 7 a.m.–6 p.m., and a summer drop-in program from 2-6 p.m. Some of the programs they offer include: power-hour for homework assistance, computer lab for math and reading enrichment, gymnasium for recreational activities, and triple play which is a mind-body-spirit focus for kids. They also have program partners and support in the community, some of which include FFA Pals, Big Brothers Big Sisters, Office of Juvenile Justice Prevention, Girl Scout Council, and Badger Alumni.
