APPROVAL OF FINAL SITE PLAN AND LEGAL DESCRIPTION FOR A RESIDENCE HALL ON THE UW ROCK COUNTY CAMPUS

WHEREAS, on November 21, 2013 the Rock County Board of Supervisors approved the transfer of not more than four acres of land to the Rock Residential Foundation, Inc., (once they are incorporated) for the purpose of building a residence hall on the UW Rock County campus; and 3

WHEREAS, final approval was dependent on approval of a final site plan and legal description by the General Services Committee and County Board; and 6

WHEREAS, UW Rock County has brought a new plan back to the County moving the project west of the previously proposed plan; and

WHEREAS, the UW Board of Regents at their last meeting approved removing approximately 5 acres out of the lease with Rock County and the General Services Committee recommended the entire approximately 5 acres be transferred to the Rock Residential Foundation, Inc.; and

WHEREAS, this property is hereby described as follows:

A part of the Northeast 1/4, Southeast 1/4, Southwest 1/4 and Northwest 1/4 of the Southeast 1/4 of Section 10, Township 2 North, Range 12 East, of the Fourth P.M., City of Janesville, Rock County, Wisconsin, bounded and described as follows:

Commencing at the Southeast corner of section 10 aforesaid; thence North 00°17'12" West along the east line of said section 10 a distance of 597.76 feet; thence South 89°27'00" West 990.14 feet; thence North 00°16'50" West 311.10 feet to the Point of Beginning for the lands herein described; thence South 89°22'32" West 384.50 feet; thence North 00°16'50" West 563.13 feet; thence North 89°43'10" East 276.00 feet; thence North 00°16'50" West 35.00 feet; thence North 89°43'10" East 108.50 feet; thence South 00°16'50" East 595.82 feet to the Point of Beginning. Containing 5.048 acres, more or less.

Subject to any and all easements, agreements, covenants or restrictions, recorded or unrecorded.
