Authorizing Contract for Nursing Home Consulting Service

WHEREAS, Rock Haven has undergone surveys within the past several months that have resulted in citations and fines; and

WHEREAS, several actions are ongoing to address the issues identified during these surveys; and

WHEREAS, at its meeting on January 15, 2015, the Health Services Committee agreed that issuing a Request for Qualifications for nursing home consulting services was an appropriate action to help identify and resolve ongoing nursing and administrative issues at Rock Haven; and

WHEREAS, two consultants responded to the Request for Qualifications; and

WHEREAS, a review committee composed of two members of the Health Services Committee, the County Board Chair, the Nursing Home Administrator, and the County Administrator interviewed both consulting firms on February 5, 2015; and

WHEREAS, the review committee has selected Pathway Health of White Bear Lake, Minnesota, to provide consulting services; and

WHEREAS, Pathway Health is able to provide services in areas that include operations assessment, policy and procedure revision and development, staff training, quality improvement planning, and extended follow-up to ensure appropriate implementation.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this 12⁴⁷ day of 2015 does hereby authorize a contract with Pathway Health in an amount not to exceed \$73,927.

Executive Summary

Over the past several months Rock Haven has undergone state surveys that identified deficiencies in several areas. The results of these surveys were multiple federal citations and fines. Based on the identified need to ensure the services provided to residents are of the highest quality, several actions have been taken to address deficiencies and improve services.

At its meeting on January 15, 2015, the Health Services Committee agreed that issuing a Request for Qualifications (RFQ) for nursing home consulting services would be an appropriate action. The RFQ asked firms to provide services including a review of nursing services, a review of the organizational and administrative structure of Rock Haven, and an emphasis on resident-centered care.

Two consultants responded to the RFQ. A review committee composed of two members of the Health Services Committee, the County Board Chair, the Nursing Home Administrator, and the County Administrator interviewed both consulting firms on February 5, 2015. The review committee selected Pathway Health of White Bear Lake, Minnesota, to provide these consulting services.

Pathway Health has proposed to provide services that include the following:

- assessment of the root causes of issues facing Rock Haven and the development of an action plan;
- policy and procedure writing and editing;
- staff training;
- Quality Assurance Performance Improvement (QAPI) plan development; and
- leadership mentoring, monitoring, and ongoing intervention/follow-up.

Pathway Health's proposal is based on an average length of engagement for a comprehensive project and includes travel costs, including for its primary consultant based in Milwaukee. However, following the assessment phase of the project, the action plan developed will provide an indication of the extent of services recommended in each of the successive areas/phases. Therefore, the \$73,927 proposed contract represents a "not to exceed" amount that may be less depending on the identified and prioritized needs. The review committee determined that this cost, while significant, represented a level of investment that would not only improve operations and care but also reduce the opportunity for further citations and fines, which have also been significant.

Pathway Health will provide no less than bi-weekly progress updates, which will be communicated to the Health Services Committee at its regular meetings. The County Board of Supervisors will also be kept informed of progress.
