EXECUTIVE SUMMARY AUTHORIZING AWARD OF CONTRACT FOR SPORTSMAN'S PARK PLAYGROUND EQUIPMENT

This resolution provides final authorization to award the contract for installation of playground equipment at Sportsman's Park in the amount of \$35,000. This resolution awards the contract to Lee Recreation, who was selected because they had the best equipment and design based on proposals received. The decision was based not only on cost, but also on the overall natural look of the equipment and how it will fit within the park's landscape. Each proposal was ranked using scoresheets that looked at the design and fit within the park, equipment colors, number and variety of play components, recycled material content, safety and ADA accessibility, budget, and insurance requirement.

The site preparation groundwork will be completed by the Rock County Department of Public Works to the bidder's requirements.

Project will be funded through the Parks Capital Improvement Account (Account 41-4592-4800-67200). This project was budgeted at \$35,000. Any site preparation and finish costs furnished by Public Works staff will be covered under the operating budget.
