

CRIMINAL JUSTICE COORDINATING COUNCIL
Minutes - October 18, 2012

Call to Order. Chair Gubbin called the meeting of the Criminal Justice Coordinating Council to order at 4:03 P.M. in the Courthouse Conference Center on the second floor of the Rock County Courthouse-East.

Approval of Agenda. Chair Gubbin moved agenda item 11 to agenda item 8. Ms. Klyve moved approval of the agenda with this modification, second by Mr. Howland. ADOPTED.

Approval of Amended Minutes from September 20, 2012. Ms. Klyve moved approval of the amended minutes, second by Mr. Pearson. ADOPTED.

Drug Court Report. Judge Werner presides over Drug Court. He mentioned there have been 179 graduates, which is about 55-60% success rate. Presently, the Court has 54-55 participants and they are expecting that number to bump up to 60 by the end of the month. The Court deals with high-risk/high-need clientele. Judge Werner said they are making progress, positive things are happening. Ms. Kraft asked for the definition of high risk. Mr. Nelson replied high-risk does not mean dangerous; violent offenders are not accepted in this program. High-risk are those individuals that have a high likelihood of committing crimes. In 2007, 1.7% of the participants in Drug Court were high-risk. So far, in 2012, the percentage of high-risk clients has reached 25%. Judge Werner explained the incentives to participate in the Drug Court Program.

Update on the Youth Services Center Short-Term Corrections Program. Mr. Horozewski disseminated a handout on Alternative to Corrections by Taking Immediate Ownership of New Skills (ACTIONS) and gave an overview of the program to the Committee. The program has capacity for four male juveniles, however, only three are currently enrolled. The juveniles are ordered into this program along with their family. Mr. Horozewski mentioned one juvenile was screened out of the program due to a lack of family involvement. A question was asked about the possibility of having adult mentors from local churches take the place of an absent parent/family, thus providing the juvenile access to this program. Mr. Horozewski replied they are checking into this.

Discussion Regarding District Attorney Workload Analysis. Mr. O'Leary informed the Committee of the workload and the pay progression his department is faced with. The State completed

a study and recommends an additional 200 Assistant DA's are needed throughout the State, with Rock County in need of 8 to 9 Assistants. The State understands the need but does not have the funding for extra positions. Mr. O'Leary mentioned he is lucky to have very experienced staff, which other DA Offices across the state do not have. Due to workload, some cases may not be prosecuted and many are plead out due to the high volume. Another concern in DA Offices throughout the state is the lack of pay increases for the attorneys.

OWI Court Update. Judge Bates said OWI Court is up and running with one participant at this time. There is a maximum of 25 participants. The Court is focusing on high-risk/high-need participants.

Discussion Regarding Law Enforcement Concerns. Chief Moore asked the Committee to consider how the county could require people arrested for or convicted of felony intoxicated driving offenses to wear alcohol-monitoring bracelets pre-trial. Chief Moore said behavior that is predictable is preventable and suggested that alcohol monitors could be ordered post-arrest as a condition of bail or post-conviction as a condition of sentence. The punishment for a repeat OWI offender caught drinking on the bracelet would be jail time. To date, Janesville has had 312 arrests for OWI and 29 have four or more arrests; last year there were 357 arrests and 42 were for a 4th offense or more. Mr. O'Leary said he is not confident OWI Court will be able to stop the cycle of repeat intoxicated drivers. He feels, along with some defense attorneys, that many third-offense offenders may find it easier to serve the jail time as opposed to do the 18 months of addiction-recovery work required to participate in OWI Court. Mr. O'Leary added that in many cases jail time is only 48 hours as required by state law and after that, offenders often are sent home on GPS monitoring bracelets. Chair Gubbin suggested this topic be added to a future agenda.

Update on Law Enforcement and Human Services Meeting Regarding 51.15. Chief Moore mentioned a meeting is set for October 30th. Beloit Hospital, St. Mary's, and Mercy agree they need to be a part of the discussion relating to 51.15 situations.

Discussion Regarding Systems Mapping. Ms. Pohlman McQuillen mentioned she has the systems mapping software and Chair Gubbin said an email would be sent out to set up work groups for this project.

Grants Update.

TAD Grant - Ms. Pohlman McQuillen stated that the application has been completed and we will be receiving approximately \$110,000, just like last year.

Federal Drug Court Grant - Nothing new to report.

CIT Grant – Ms. Pohlman McQuillen said there would be funding available through OJA for additional training in 2013. It is her understanding the City of Janesville PD, City of Beloit PD, Town of Beloit PD, and the Sheriff's Office are interested in participating again.

CJCC Grant. - A RFQ went out to hire a consultant to work on strategic planning and implementation processes.

Areas of Future Action and Discussion for CJCC. Chair Gubbin said this was previously mentioned earlier.

Citizen Participation and Announcements. Ms. Pohlman McQuillen mentioned there is a Process and Opportunities Sub-Committee next Thursday (Oct. 25th) at noon.

Mr. O'Leary announced Ray Jablonski, Assistant District Attorney, is retiring after 35 years. There will be an open house in the CCC tomorrow from 2:00 P.M. – 4:00 P.M., all are welcome. Mr. O'Leary also mentioned the Governor appointed him to the State-wide CJCC.

Ms. Klyve said Rock Valley would provide services to Jackson House clients beginning January 1, 2013. Rock Valley has a separate wing for crisis along with 15 beds. The clients will hopefully be able to continue their treatment locally.

Future Meeting Date. The next CJCC meeting is Thursday, November 15, 2012, Courthouse Conference Center at 4:00 P.M.

Adjournment. The meeting adjourned by acclamation at 5:30 P.M.

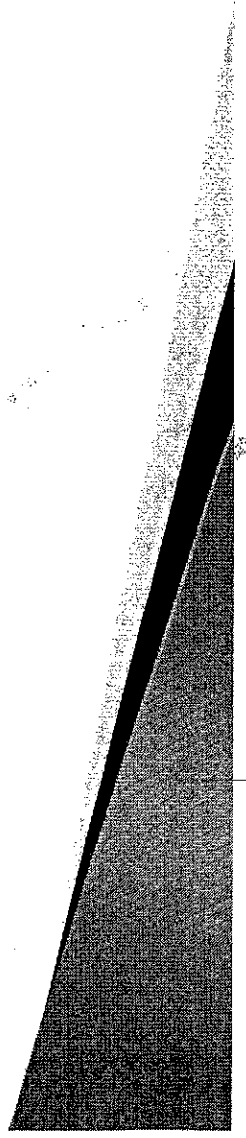


Program Overview




MISSION
