# **Awarding the Contract for Exterior Wall Restoration at the Courthouse**

WHEREAS, \$200,000 was budgeted in 2022 for the exterior wall restoration at the Courthouse building; and

WHEREAS, the masonry, tuck-pointing and caulking needs are immediate to prevent further structural damage and ongoing water leaks; and

**WHEREAS**, the tuck-pointing for the Courthouse is extensive and is being completed over a multi-year budget cycle with 2024 being the final year; and

WHEREAS, specifications were drafted, and bids solicited with Five (5) contractors submitting bids; and

WHEREAS, the lowest most responsive and responsible bidder is Corporate Contractors Inc. in the amount of \$225,000;and

WHEREAS, because this is a multi-year project the consultant worked with CCI to reduce the linear feet to get us within budget; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Rock County Board of Supervisors duly assembled this <u>24th</u> day of <u>March</u>, 2022 does hereby approve and authorize awarding a contract in the amount of \$187,000 to Corporate Contractors Inc, out of Beloit WI for the exterior wall restorations at the Courthouse.

# "Executive Summary"

# Awarding the Contract for Exterior Wall Restoration at the Courthouse

The resolution award's a contract for tuck pointing and caulking of the exterior masonry walls at the Courthouse building. This work is extensive and will be completed over a multi-year budget cycle with a final completion in 2024. This work is necessary to prevent further deterioration caused by water damage behind the wall.

Bids were solicited with Five (5) contractors responding. The lowest, most responsive, and responsible bidder, Corporate Contractors Inc of Beloit, Wisconsin, in the amount of \$225,000. We had \$200,000 budgeted and spent \$13,000 for consulting, leaving a balance of \$187,000. Because this is a multi-year project, our consultant worked with CCI and reduced the linear feet to get us within budget for 2022.
