Acceptance of Office of Juvenile Justice and Delinquency Prevention (OJJDP) Family Drug Court Program Grant Funds and Creation of 2.0 FTE Human Services Professionals and 1.0 FTE Psychiatric Technician Positions

WHEREAS, the U.S. Office of Justice Programs, through the Office of Juvenile Justice and Delinquency Prevention (OJJDP), has appropriated funding for grants to enhance and expand family treatment court services to increase collaboration with substance-use treatment and child welfare systems to ensure the provision of treatment and other services for families that improve child, parent, and family outcomes; and,

WHEREAS, Rock County submitted an application to expand its Family Recovery Court (FRC) Treatment Court Program to enhance and improve the services offered to participants, increase capacity, and add additional services FRC is currently unable to provide; and,

WHEREAS, on December 16, 2021, Rock County's application was approved and Rock County has been awarded federal funding in the amount of \$996,944 with a requirement to also generate \$3,000 in program income; and,

WHEREAS, this expansion grant, over 36 months beginning October 1, 2021, will be primarily used to hire 2.0 FTE Human Services Professionals and 1.0 FTE Psychiatric Technician, and provide the corresponding supports to expand the FRC program to increase capacity from 15 to 30 participants at any given time.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this <u>14th</u> day of <u>April</u>, 2022, does hereby accept the OJJDP Family Drug Court Program Grant funds in the amount of \$996,944 in federal aid.

BE IT FURTHER RESOLVED, the County Board approves the creation of the grant-funded 2.0 FTE Human Services Professional and 1.0 FTE Psychiatric Technician positions and authorizes the Human Services Department to fill these positions; and,

BE IT FURTHER RESOLVED, that the 2022 Rock County Human Services Department budget be amended as follows:

Executive Summary

Acceptance of OJJDP Family Drug Court Program Grant Funds and Creation of 2.0 FTE Human Services Professional and 1.0 FTE Psychiatric Technician Positions

The U.S. Office of Justice Programs, through the Office of Juvenile Justice and Delinquency Prevention (OJJD), has appropriated funding for grants to enhance and expand family treatment court services to increase collaboration with substance use treatment and child welfare systems to ensure the provision of treatment and other services for families that improve child, parent, and family outcomes.

Rock County submitted an application to expand its Family Recovery Court (FRC) Treatment Court Program to enhance and improve the services offered to participants, increase capacity, and add additional services FRC is currently unable to provide.

On December 16, 2021, Rock County's application was approved in the amount of \$996,944 in federal aid. In addition the program is expected to generate \$3,000 in program income. There is an in-kind match requirement of \$332,315 that will be covered with existing county staff time.

This expansion grant, over 36 months beginning October 1, 2021, will be primarily used to hire 2.0 FTE Human Services Professional and 1.0 FTE Psychiatric Technician positions. Of the 2.0 FTE Human Services Professional positions one will be a Master's level, dually credentialed Behavioral Health Clinician and the other will be a Bachelor's level Substance Use Case Manager. The remaining funding will be used for corresponding supports to expand the FRC program to increase capacity to 30 participants at any given time.
