WHEREAS, the PSC's Wisconsin Broadband Office encourages coordination and partnership between telecommuting stakeholders by certifying local communities as being Telecommuter Forward!; and,

WHEREAS, Established in 2017 under WI. Act 342, Telecommuter Forward! is a voluntary program for local units of government (city, village, town, or county) to signal that the political subdivision supports and commits to promote the availability of telecommuting options.

- 4. Promotion of telecommuter-friendly workspaces, such as business incubators with telecommuting spaces, if such a workspace has been established in the political subdivision at the time the political subdivision adopts the resolution.
- 5. Familiarity with broadband mapping tools and other state-level resources.
- 6. Maintaining regular communication with the state broadband office.
- 7. Making regular reports to the Planning and Development Committee and/or the Rock County Board of Supervisors.
