# <u>Authorizing Purchase of Two 72" Mowers for Use at New Property - 5801 North River Road,</u> <u>Janesville, WI</u>

**WHEREAS**, the Rock County Board of Supervisors voted unanimously to purchase a 178 acre property located at 5801 N. River Road formally known as Camp Indian Trails owned and operated by the Boy Scouts of America, and,

**WHEREAS**, the Rock County Board of Supervisors also voted to authorize funding in the amount of \$650,000 for Capital Improvement and Maintenance Items for this property, and,

WHEREAS, Johnson Tractor, Janesville, WI, is authorized to sell Kubota Equipment under Sourcewell contract 040319-KBA for grounds maintenance equipment, and,

**WHEREAS**, the Parks Department did review the specifications for compliance and recommends the purchase of two (2) Kubota ZD1211L 72"mowers from Johnson Tractor, Janesville, WI.

**NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board duly assembled this <u>14th</u> day of <u>April</u>, 2022, authorize that a Purchase Order be issued to Johnson Tractor, Janesville, WI for \$32,620.44 for the purchase of two (2) Kubota ZD1211L 72" mowers.
