# Accepting Dean Health Plan Wellness Grant Award and Amending the 2022 Wellness Program Budget

WHEREAS, the County's Wellness Program Mission and Purpose are to improve the overall health of Rock County Employees and their families by providing wellness challenges and opportunities to enhance and encourage healthy lifestyles; and to obtain measurable results by tracking wellness activities, challenges and events to make a positive impact on health care costs and to assist the County in health insurance cost containment.

WHEREAS, the Wellness Program offers a variety of programming, including the promotion of the Wellness Ceenter located at the Dr. Daniel Hale Williams Rock County Resource Center; and,

**WHEREAS**, the Dean Health Plan Wellness Grant program awarded a \$2,000 grant to the County Wellness Program that will be used for purchase of equipment, Wellness Center supplies, Wellness Programming and Wellness Challenge prizes and benefit fair incentives.

**NOW, THEREFORE BE IT RESOLVED** by the Rock County Board of Supervisors assembled this <u>26th</u> day of <u>May</u> 2022, that the Rock County Wellness Program is authorized to accept the Dean Health Wellness Grant Program award in the amount of \$2,000.

#### **Executive Summary**

The County's Rock & Wellness Program was recently notified that it was awarded \$2,000 from Dean Health Plan Wellness Grant Program.

The County's Wellness Program Mission and Purpose are:

- Mission: To improve the overall health of Rock County Employees and their families by providing wellness challenges and opportunities to enhance and encourage healthy lifestyles.
- Purpose: To obtain measurable results by tracking wellness activities, challenges and events to make a positive impact on health care costs and to assist the County in health insurance cost containment.

The funds will be used for the following Wellness Program activities:

Equipment or wellness center supplies: \$750

Wellness programming: \$500

Challenge prizes and benefit fair incentives etc.: \$750

Total \$2,000
