Narcotics Search Warrants Served in the City of Beloit

On June 2, 2022, at approximately 5:00 a.m., the Rock County Sheriff's Office SWAT Team executed a search warrant secured by the Rock County Sheriff's Office Special Investigations Unit (SIU) at 1722 Chapman Avenue, Beloit, WI 53511. Simultaneously, the City of Beloit Police Department Tactical Operations Unit executed a separate search warrant secured by SIU at 1011 Oak Street, Beloit, WI 53511. Later in the day, SIU and the Rock County Sheriff's Office Detective Bureau served a related search warrant at 2237 Burton Street, Apartment # 38, Beloit, WI 53511.
