#### 36 4.1403 Point of Contact.

 The Public Works Department shall be designated as the single point of contact for all matters related to a broadband network project. The Public Works Department shall provide on its public website the contact information, including the e-mail address, for the point of contact authorized to receive a broadband network project application.

# **4.1404** Electronic Submission of Applications.

An applicant may sign and file all forms, applications and documentation related to a broadband network project electronically.

## 48 4.1405 Review of Applications.

Notwithstanding any other provision in the County of Rock's ordinances, resolutions, regulations, policies, or practices to the contrary, the following process shall apply exclusively upon receiving a broadband network project application:

- (1) Completeness review. Upon receiving a broadband network project application, the Public Works Department shall:
  - (A) Determine whether an application is complete and notify the applicant of the determination by the Public Works Department in writing within 10 calendar days of receiving an application. If the Public Works Department does not notify the applicant in writing of its completeness determination within 10 calendar days of receiving the application, the application shall be considered complete.
  - (B) If the Public Works Department determines that an application is not complete, the written notification to the applicant shall specify in detail the required information that is not complete. The applicant may resubmit an application as often as necessary until the application is complete.
- (2) Approval or denial of complete applications.
  - (A) Within 60 calendar days of receiving an application that is complete or considered complete under sub. (1), the Public Works Department shall approve or deny the application and provide the applicant written notification of the approval or denial. If the Public Works Department does not notify the applicant of its approval or denial within 60 calendar days of receiving a complete application, the application shall be considered approved and any required permit shall be considered issued.
  - (B) If the Public Works Department denies an application, the written notification of the denial under sub. (1) shall include evidence that the denial is not arbitrary and capricious.

### 84 4.1406 Fees.

Any fee imposed by the Public Works Department to review an application, issue or permit or perform any other activity related to a broadband network project shall be reasonable. An application fee that exceeds \$100 is unreasonable. Fees shall be consistent with the fee schedule provided in the Rock County Utility Accommodation Policy.

#### 92 4.1407 Initial Applicability.

The treatment of this ordinance applies to applications received by the Public Works Department on or after the effective date of this ordinance.

II. This ordinance shall be effective upon publication.

## **Executive Summary**

# Ordinance - Creating Broadband Network Project Chapter

This Ordinance would create a new chapter for broadband network projects in conjunction with the recently submitted Public Service Commission Broadband Expansion grant application. The Public Service Commission certifies communities as being "broadband ready" by issuing a Broadband Forward! Certification that signals a local unit of government has taken steps to reduce obstacles to broadband infrastructure investment.

Adopting the Broadband Forward! Community Model Ordinance and obtaining Broadband Forward! Certification ensures the local unit of government has streamlined its administrative procedures by:

- 1. Appointing a single point of contact for all matters relating to a broadband network project.
- 2. Adhering to a timely approval process.
- 3. Charging only reasonable fees for reviewing applications and issuing permits.
- 4. Imposing only reasonable conditions on a permit and
- 5. Not discriminating between telecommunications service providers.

The above protocols provide a platform for broadband development in Rock County and is appropriate that the Public Works Department be assigned responsibility.
