WHEREAS, the Wisconsin Department of Health Services administers the Qualitative Data for Capacity Building and Alignment Grant, which provides funding to local health departments; and,

WHEREAS, the funding is intended to support the health department's ability to gather input from communities experiencing disproportionate impacts of health inequities; and,

WHEREAS, the Rock County Public Health Department will use the funding to partner with grassroots community leaders to co-facilitate community conversations; and,

WHEREAS, the community conversations will help to identify future strategies to improve the public's health; and,

WHEREAS, the funding is for the time period of June 30, 2022 - May 31, 2023.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this https://dx.doi.org/10.1171/14 day of August, 2022 does hereby authorize Rock County Public Health Department to accept funding of \$34,710 through the Wisconsin Department of Health Services Qualitative Data for Capacity Building and Alignment Grant and amend the 2022 Rock County Public Health Department budget as follows:
