Accepting Overdose Fatality Reviews Grant Funds and Amending the 2022 Rock County Public Health Department Budget

WHEREAS, the Medical College of Wisconsin administers an Overdose Fatality Reviews Grant, which provides funding to facilitators of Overdose Fatality Reviews; and,

WHEREAS, Rock County Public Health Department facilitates a newly established Overdose Fatality Review to identify opportunities to prevent future overdose deaths in Rock County; and,

WHEREAS, the Rock County Public Health Department will use the funding to prepare for and facilitate the review meetings and work with partners to implement strategies identified through the reviews; and,

WHEREAS, the funding is for the time period of July 1, 2022 – August 31, 2023.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this 11th day of August, 2022 does hereby authorize Rock County Public Health Department to accept funding of \$44,797 through the Medical College of Wisconsin's Overdose Fatality Review Grant and amend the 2022 Rock County Public Health Department budget as follows:

EXECUTIVE SUMMARY:

Accepting Overdose Fatality Reviews Grant Funds and Amending the 2022 Rock County Public Health Department Budget

The Rock County Public Health Department has been awarded funds through the Medical College of Wisconsin to support the facilitation of an Overdose Fatality Review. Overdose Fatality Reviews bring together community partners involved in responding to overdose deaths and partners who provide care to individuals experiencing substance use disorders to identify strategies to prevent future overdose deaths. Funding from the grant will support personnel costs of existing staff members who will be supporting the project and will also cover associated travel.
