### Hispanic Heritage Month

Many Hispanic Americans can trace their roots back to the cultures of the Americas' indigenous peoples, including the Aztecs (Mexico), Arawaks(Puerto Rico), Incas (South America), Maya (Central America) and Tainos (in Cuba and Puerto Rico). Some of their roots can be traced back to the Spanish explorers, who set out in the 1400s to find a cheaper and easier way to trade with the Indies. Other Latinos can trace their roots back to African slaves brought to the New World.

Hispanic Americans are today identified by the countries from which they or their ancestors originated. This includes Mexico, Puerto Rico, and Spain. This observation began in 1968 under President Lyndon Johnson as Hispanic Heritage Week. President Ronald Reagan expanded it in 1988 to include a 30-day period that started on September 15th and ended on October 15. The Public Law 100-402 approved it, and it was made law on August 17, 1988.

#### Dolores Huerta

Dolores Clara Fernandez Huerta is one of the most influential labor activists of the 20<sup>th</sup> century and a leader of the Chicano civil rights movement

Huerta was the driving force behind the ground-breaking California Agriculture Labor Relations Act of 1975, which allowed farm workers to form unions and bargain for better wages and conditions.

Huerta received the Eleanor Roosevelt Human Rights Award in 1998 and the Presidential Medal of Freedom in 2012. As of 2015, she was a board member of the Feminist Majority Foundation, the Secretary-Treasurer Emeritus of the United Farmworkers of America, and the President of the Dolores Huerta Foundation.

### The Difference Between Hispanic & Latino

Hispanic and Latino are often used interchangeably though they mean two different things. Hispanic refers to people who speak Spanish and/or are descended from Spanish-speaking populations, while Latino refers to people who are from or descended from people from Latin America. In today's United States, these terms are often thought of as racial categories and are often used to describe race, in the way that we also use white, Black, and Asian. However, the populations they describe are composed of various racial groups, so using them as racial categories is inaccurate. They work more accurately as descriptors of ethnicity, but even that is a stretch given the diversity of people they represent.

That said, they are important as identities for many people and communities, and they are used by the government to study the population, by law enforcement to study crime and punishment, and by researchers of many disciplines to study social, economic, and political trends, as well as social problems. For these reasons, it's important to understand what they mean literally, how they are used by the state in formal ways, and how those ways sometimes differ from how people use them socially.
