Authorizing Acceptance of Rock County Equity Project Grant Funds and Amending the 2022 Budget

WHEREAS, Alia will award \$85,000 of grant funding to the Rock County Human Services Department to provide real-time support to families and kinship providers in order to prevent out-of-home placement and preserve family connections; and,

WHEREAS, this one year grant, beginning July 1, 2022, will be primarily used to provide tangible support for families involved with the Rock County Human Services Department's Child Protective Services Unit in an effort to preserve family connections; and,

WHEREAS, this funding allows leaders to be creative and responsive to meet the needs of families; and,

WHEREAS, the goal of this funding is to demonstrate the effectiveness of real-time supports that can prevent out-of-home placements and make a difference for child outcomes.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this <u>27th</u> day of <u>October</u>, 2022 does hereby accept the grant funds in the amount of \$85,000.
