## Awarding the Contract for the Renovation of the Law Library

WHEREAS, The Law Library space on 4<sup>th</sup> floor of the Courthouse is currently empty; and

WHEREAS, funds of \$500,000 was budgeted to convert the vacate room into a functioning hearing room; and

**WHEREAS**, Venture Architects worked with the Judges, Court Commissioners, Clerk of Courts, Rock County IT and Facilities Management to design very functional hearing room; and

WHEREAS, specifications were drafted, and bids solicited with (3) three contractors submitting bids for construction; and

WHEREAS, the lowest, most responsive, and responsible bidder was Glen Fern out of Lake Genva, WI

**NOW, THEREFORE, BE IT RESOLVED**, that the Rock County Board of Supervisors duly assembled this <u>27th</u> day of <u>October</u>, 2022 does hereby approve and authorize awarding a contract in the amount of \$290,995 to Glen Fern of Lake Geneva, WI for the renovation of the former law library space.

**BE IT FURTHER RESOLVED,** a contingency fund of \$ 29,000 will be established to cover any unforeseeable issues that arise.

**BE IT FURTHER RESOLVED,** approves contracting with Hendricksen under OMNIA R191802 National contract pricing for the purchase of movable furniture for this project in the amount of \$15,000.

### **Executive Summary**

Awarding the contract for the renovation of the Law Library. Bids were solicited with (3) three bidders responding. The lowest most responsible and responsive bidder was Glen Fern of Lake Geneva WI, in the amount of \$290,995 for construction costs. A 10% contingency of \$29,000 is also being requested.

Furniture will be purchased from Hendricksen under OMNIA R191802 national contract pricing in the amount of \$15,000.

**Background Information:** In 2022 facilities management budget included funds of \$500,000 to convert the Law Library and the Probate Vault into court hearing rooms. Venture Architects worked with the Judges, Court Commissioners, Clerk of Courts Rock IT and Facilities Management to design the hearing rooms and draft the specifications for bidding. Bids were solicited with (3) three bidders responding. Glen Fern Construction's bid was rejected due to failing to provide the required bid documents. They did not complete and submit the Bidders Qualification forms.

On July 26,2022 a resolution to contract with the lowest most responsible and responsive bidder was JP Cullen and Sons of Janesville WI, in the amount of \$654,320 for construction costs. Due to the market price increases the project costs came in over budget and we had requested a budget amendment to cover the cost difference with the use of prior year sales tax in the amount of \$373,891. That resolution was recommended by General Services Committee on July 19,2022. On July 28,2022 this resolution was not approved by the County Board. General Services Committee on August 23,2022 voted to approve separating the two spaces as separate projects and rebid just the law library.
