Authorizing the Human Services Department to Enter Into Contracts for Comprehensive Community Services

WHEREAS, the Comprehensive Community Services (CCS) program in the Human Services Department (HSD) is a community-based psychosocial rehabilitation program providing treatment to children and adults with mental illness, substance abuse, or a co-occurring diagnosis focused on removing barriers to independence and improving quality of life; and,

WHEREAS, to meet consumer needs HSD contracts with multiple providers to provide an array of individual and group psychosocial rehabilitation services to adults, children, and families that includes Service Planning, Diagnostic Evaluations, Skill Development, Psychoeducation, Psychotherapy, Wellness Management and Recovery Services, Substance Abuse Treatment, and Medication Management; and,

WHEREAS, the Human Services Department (HSD) is requesting to enter into contract with Professional Services Group, Inc. (PSG) for an amount up to \$350,000 and with Orion Family Services Inc. for an amount up to \$450,000 for services that provide support to community members served through the Comprehensive Community Services (CCS) program; and,

WHEREAS, services are provided in compliance with Wisconsin Administrative Code DHS 36 and based on the consumer’s specific Individual Support Plan that is completed with the consumer, their care team, and approved by a mental health professional; and,

WHEREAS, HSD has contracted with PSG and Orion Family Services for several years for these services; and,

WHEREAS, PSG and Orion Family Services have office locations in Rock County and provide services throughout the community; and,

WHEREAS, Psychosocial Rehabilitation services provided through CCS are fully funded through Medical Assistance; and,

WHEREAS, funds are included in the 2023 HSD Adopted budget.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this 15th day of December, 2022, does authorize the Human Services Department to enter into a contract with Professional Services Group, Inc. for the amount of \$350,000 and with Orion Family Services, Inc. for the amount of \$450,000.

FISCAL NOTE:

Executive Summary

AUTHORIZING THE HUMAN SERVICES DEPARTMENT TO ENTER INTO CONTRACTS FOR COMPREHENSIVE COMMUNITY SERVICES

The Human Services Department (HSD) is requesting authorization to enter into contract with Professional Services Group, Inc. (PSG) for a projected amount of \$350,000 and with Orion Family Services, Inc. for a projected amount of \$450,000 in 2023. The contract is for services rendered in the Comprehensive Community Services (CCS) program for which expenses are fully funded and reimbursed through Medical Assistance. HSD anticipates these two providers will serve approximately 130 clients in 2023.

Comprehensive Community Services (CCS) is a program that offers community-based Psychosocial Rehabilitation services to members of the community with mental health and/or substance use issues. Community members utilizing CCS services will work with a care team of their choosing to determine short- and long-term goals for recovery as well as any services and supports needed to assist in making progress towards those goals.

PSG offers services to the CCS program at four professional levels: 1) Bachelors, 2) Masters, 3) Doctorate (PhD), and 4) Advanced Practice Nurse Practitioner (APNP).

Orion Family Services offers services to the CCS program at three professional levels: 1) Rehabilitation Worker, 2) Bachelors, and 3) Masters.

The professional level of any person providing services to CCS members are all determined by an evaluation of their level of education, training, credentials, and prior experience.

Rehabilitation Worker: Orion Family Services' Rehabilitation Worker services include Service Planning, Skill Development, and Wellness Management and Recovery Support. These Services are reimbursed at \$55.88 per hour.

Bachelors: PSG's Bachelor level services include Service Planning, Service Facilitation, Skill Development and Enhancement, and Psychoeducation. These services are reimbursed at \$82.00 per hour of individual services and \$20.50 per hour of group services.

Orion Family Services' Bachelor level services include Service Planning, Service Facilitation, Skill Development and Enhancement, Wellness Management and Recovery Support, Psychoeducation, and Substance Abuse Treatment. These services are reimbursed at \$82.84 per hour.

Masters: PSG's Masters level services include Service Planning, Service Facilitation, Skill Development and Enhancement, Wellness Management and Recover Support, Substance Abuse Treatment, Psychoeducation, Psychotherapy, and Diagnostic Evaluation. These services are reimbursed at \$120.00 per hour of individual services and \$30.00 per hour of group services.

Orion Family Services' Masters level services include Service Planning, Service Facilitation, Skill Development and Enhancement, Wellness Management and Recovery Support, Psychoeducation, and Substance Abuse Treatment. These services are reimbursed at \$110.92 per hour.

Masters level Substance Abuse Treatment, Psychotherapy, and Diagnostic Evaluation is provided by licensed and credentialed Masters level professionals.

Doctorate (PhD): PSG's Doctorate (PhD) level services include Service Planning, Service Facilitation, Skill Development and Enhancement, Wellness Management and Recovery Support, Substance Abuse Treatment, Psychoeducation, Psychotherapy, and Diagnostic Evaluation. These services are reimbursed at a rate of \$153.24 per hour.

Doctorate level Substance Abuse Treatment, Psychotherapy, and Diagnostic Evaluation is provided by licensed and credentialed Doctorate level professionals.

Advanced Practice Nurse Practitioner (APNP): PSG's APNP level services include Medication Management and Psychoeducation. These services are reimbursed at a rate of \$200.00 per hour.

All Services at this level are provided by a licensed and credentialed Advanced Practice Nurse Practitioner.

PSG and Orion Family Services offer these services in satellite offices located in the Janesville community. PSG and Orion Family Services also provide services directly to members in their home or place of choosing within the community.
