Authorizing the Human Services Department to Enter Into Contracts for Residential Placements

WHEREAS, the Human Services Department (HSD) has multiple community-based programs providing services to adults with mental illness, substance abuse, or a co-occurring diagnosis focused on removing barriers to independence and improving quality of life; and,

WHEREAS, to meet consumer needs HSD contracts with multiple residential providers to provide an array of residential options to best meet the needs of the individuals needing services; and,

WHEREAS, the Human Services Department (HSD) is requesting to enter into contracts with Productive Living Systems, Inc (PLS) for an amount up to \$500,000; with Root Residential Adult Family Homes, LLC (Root AFH) for an amount up to \$450,000; and Trempealeau County Health Care Center (Trempealeau) for an amount up to \$350,000 for residential services of various supervision levels to meet the needs of individuals served in the community based programs provided by HSD; and,

WHEREAS, services are provided in compliance within the administrative codes and State Statutes that regulate these residential settings and HSD provides a level of oversight to manage health and safety of the individuals receiving these services; and,

WHEREAS, HSD has contracted with PLS, Root AFH and Trempealeau for several years for these services; and,

WHEREAS, PLS, Root AFH and Trempealeau have office locations in the State of Wisconsin and provide services throughout the county and state; and,

WHEREAS, funds are included in the 2023 HSD Adopted budget.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this 12th day of January, 2022, does authorize the Human Services Department to enter into contracts with Productive Living Systems, Inc (PLS) for an amount up to \$500,000; with Root Residential Adult Family Homes, LLC (Root AFH) for an amount up to \$450,000; and Trempealeau County Health Care Center (Trempealeau) for an amount up to \$350,000.

Executive Summary

AUTHORIZING THE HUMAN SERVICES DEPARTMENT TO ENTER INTO CONTRACTS FOR COMPREHENISVE COMMNITY SERVICES

The Human Services Department (HSD) has multiple community-based programs providing services to adults with mental illness, substance abuse, or a co-occurring diagnosis focused on removing barriers to independence and improving quality of life. In order to meet consumer needs HSD contracts with multiple residential providers to provide an array of residential options to best meet the needs of the individuals needing services.

HSD is requesting authorization to enter into contracts with Productive Living Systems, Inc (PLS) for an amount up to \$500,000; with Root Residential Adult Family Homes, LLC (Root AFH) for an amount up to \$450,000; and Trempealeau County Health Care Center (Trempealeau) for an amount up to \$350,000 for residential services of various supervision levels to meet the needs of individuals served in the community-based programs provided by HSD in 2023.

HSD funds residential services to individuals receiving services through the behavioral health community-based programs as well as through the Adult Protective Services (APS) unit in the Aging and Disability Resource Center (ADRC).

PLS offers services that are licensed under the following levels: Community Based Residential Facility, Adult Family Home, and Supported Apartment.

Root AFH offers services that are licensed under the following levels: Community Based Residential Facility and Adult Family Home.

Trempealeau offers inpatient residential services to individuals who need an inpatient level of care while they receive treatment to assist them with moving to a residential setting that is considered a less restrictive environment.

These providers offer services in communities throughout Wisconsin and have various settings available to meet the individual needs of the participants in the community based behavioral health programs and APS program.
