# Accepting NG9-1-1 GIS Grant, Approving Purchase of Datamark Software and Services and Amending the 2023 Budget

WHEREAS, the Rock County Communications Center is the sole public safety answering point in Rock County; and,

WHEREAS, in April of 2022 the Rock County Communications Center signed a Participation Agreement with the State of Wisconsin Department of Military Affairs to join the State's Project to implement and upgrade to NextGen9-1-1 services; and,

**WHEREAS**, the Wisconsin Department of Military Affairs/Office of Emergency Communications has awarded the Rock County Land Information Office state funding through the NG9-1-1 GIS Grant Program to assist in data creation, preparation, and remediation activities for enabling NG9-1-1 in the amount of \$32,500; and,

WHEREAS, the Communications Center received a proposal for \$32,500 for software and professional services from Datamark, the Public Safety Division of Michael Baker International, Inc., dated October 20, 2022; and,

WHEREAS, grant conditions require Rock County to cover the total cost of the project prior to receiving 95% reimbursement in the amount of \$30,875 after completion of the project; and,

**WHEREAS**, Rock County will ultimately be responsible to provide the 5% match in the amount of \$1,625; and,

WHEREAS, the Land Information Office's budget requires an amendment to allow this purchase.

**NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board of Supervisors duly assembled this <u>12th</u> day of <u>January</u>, 2023, authorizes the purchase in the amount of \$32,500.00 to be awarded to Datamark, the Public Safety Division of Michael Baker International, Inc., and approves the budget amendments as follows:

#### **EXECUTIVE SUMMARY**

Accepting NG9-1-1 GIS Grant, Approving Purchase of Datamark Software and Services and Amending the 2023 Budget

The Rock County Land Information Office was awarded state funding through the Wisconsin NG9-1-1 GIS Grant Program to assist in data creation, preparation, and remediation activities for enabling NG9-1-1.

The Land Information Office submitted a GIS proposal for \$32,500.00 for software and services from Datamark, the Public Safety Division of Michael Baker International, Inc.

This grant requires the total costs to be paid for up front by Rock County. Once the project is complete, the county will be reimbursed 95% (\$30,875.00) and will be responsible for the remaining 5% (\$1,625.00).

This project was not included in the Land Information Office's 2023 budget; therefore, the purchase will require a budget amendment as noted in the resolution.
