Amending the 2023 Human Services Department Budget to Accept Additional Targeted Safety Support Grant Funds and Creating 1.0 FTE Lead Worker and 1.0 FTE Human Services Professional VI

WHEREAS, the Wisconsin Department of Children and Families allocated \$493,358 of additional funding for the Targeted Safety Support Grant Funds; and,

WHEREAS, Rock County will provide \$48,793 in county match which is already included in the HSD 2023 adopted budget; and,

WHEREAS, the program is designed to monitor and support safety plans, train and support Child Protective Services (CPS) staff in safety management, develop informal supports within family systems, enhance protective factors, and provide coverage for safety management, monitoring and crisis response to families; and,

WHEREAS, the target population served by this project are families involved with CPS who have been determined to be unsafe based on a standardized safety assessment; and,

WHEREAS, the long term goals of the initiative are to improve child safety outcomes, increase the availability of safety service resources, enhance family protective factors, decrease the need for CPS involvement, and increase the ability of CPS workers to assess safety and develop effective safety plans; and,

WHEREAS, this expansion will be used to hire a 1.0 FTE Lead Worker, a 1.0 FTE Human Services Professional VI and provide additional funding for housing, day care, respite, and other concrete resources.

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this <u>26th</u> day of <u>January</u>, 2023, does hereby authorize the acceptance of additional Targeted Safety Support Grant funding.

BE IT FUTHER RESOLVED, the County Board approves the creation of the grant-funded 1.0 FTE Lead Worker and 1.0 FTE Human Services Professional VI (Outpatient Therapist).

Executive Summary

Amending the 2023 Human Services Department Budget to Accept Additional Targeted Safety Support Grant Funds and Creating 1.0 FTE Lead Worker and 1.0 FTE Human Services Professional VI

The Wisconsin Department of Children and Families has allocated additional funding for the Targeted Safety Support Grant. This funding is to enhance and expand targeted safety support that is designed to monitor and support safety plans, develop informal supports within family systems, enhance protective capacities for parents, and train Child Protective Services (CPS) staff in safety management. Rock County was awarded \$493,358 in federal funds and will provide \$48,793 in county match which is already included in the HSD 2023 adopted budget. These funds will be primarily used to hire a 1.0 FTE Lead Worker and a 1.0 FTE Human Services Professional VI (Outpatient Therapist) and provide additional funding for housing, day care, respite, and other concrete resources for families. These positions support the Butler Institute recommendations to further support access to quality behavioral health services as well as the consistent implementation of in-home safety plans across the CPS division.
