Authorizing Acceptance of the 2023 Anti-Methamphetamine Task Force Grant and Amending the 2023 Sheriff's Office Budget

WHEREAS, the Wisconsin Department of Justice, Division of Criminal Investigation (DCI), has been selected as a recipient of the 2023 COPS Office Anti-Methamphetamine Task Force; and,

WHEREAS, the Rock County Sheriff's Office has been invited to be part of the Task Force; and,

WHEREAS, the purpose of the grant is to allocate additional resources for local, multi-jurisdictional, drug task forces; and,

WHEREAS, the Rock County Sheriff's Office is eligible to receive \$2,500 for participating in this grant; and,

WHEREAS, grant funds will be used for overtime wages; and,

WHEREAS, the grant does not require a local match; and,

WHEREAS, the grant runs from January 1, 2023 through December 31, 2023.

NOW, THEREFORE BE IT RESOLVED by the Rock County Board of Supervisors assembled this <u>26th</u> day of <u>January</u> 2023, that the Rock County Sheriff is authorized to accept funds under the Anti-Methamphetamine Task Force Grant.
