**Authorizing Acceptance of the Anti-Heroin Task Force Grant and Amending the 2023 Sheriff's Office Budget**

**WHEREAS**, the Wisconsin Department of Justice, Division of Criminal Investigation (DCI), has been selected as a recipient of the 2023 COPS Office Anti-Heroin Task Force; and,

**WHEREAS**, the Rock County Sheriff's Office has been invited to be part of the Task Force; and,

**WHEREAS**, the purpose of the grant is to allocate additional resources for local, multi-jurisdictional, drug task forces; and,

**WHEREAS**, the Rock County Sheriff's Office is eligible to receive \$10,000 for participating in this grant; and,

**WHEREAS**, grant funds will be used for overtime wages; and,

**WHEREAS**, the grant does not require a local match; and,

**WHEREAS**, the grant runs from January 1, 2023 through December 31, 2023.

**NOW, THEREFORE BE IT RESOLVED** by the Rock County Board of Supervisors assembled this 26th day of January 2023, that the Rock County Sheriff is authorized to accept funds under the Anti-Heroin Task Force Grant.

## EXECUTIVE SUMMARY

### Authorizing Acceptance of Anti-Heroin Task Force Grant and Amending the Sheriff's Office Budget

The Wisconsin Department of Justice, Division of Criminal Investigation (DCI), has been selected as a recipient of the 2023 COPS Office Anti-Heroin Task Force. The Rock County Sheriff's Office has been invited to be part of the Task Force.

The purpose of the grant is to allocate additional resources for local, multi-jurisdictional, drug task forces. Reimbursement will be provided to agencies, for overtime pay expenses, incurred during heroin and opiate investigations.

The Rock County Sheriff's Office is eligible to receive \$10,000 for participating in this grant. The grant funds will be used for overtime wages only. Benefits will not be reimbursed. The grant does not require a local match. The grant runs from January 1, 2023 through December 31, 2023.
