WHEREAS, HSD will utilize the funding to reimburse relative caregivers in line with the guidelines of the uniform foster care rate; and,

WHEREAS, the funding will create equity in the financial support offered to unlicensed relatives and kinship providers at the time of placement; and,

WHEREAS, the funding period for the grants is October 1, 2022 through September 29, 2023.

Executive Summary

Amending the 2023 Human Services Department Budget to Accept Relative Caregiver Support Grant Funds

The Wisconsin Department of Children and Families awarded the Human Services Department \$8,000 for Relative Caregiver Support Grant funds.

With this grant, Rock County Human Services will provide Relative Caregivers reimbursement for clothing needs for the children in their care. Rock County will allocate funding to relatives in line with the guidelines of the uniform foster care rate. This funding will create equity in the financial support offered to unlicensed relatives and kinship providers at the time of placement. We anticipate that this funding will be able to support between 30 and 50 children involved in our system.

The funding period for this grant is October 1st, 2022 through September 29th, 2023.
