# **Authorizing Purchase of Tek84 Intercept Whole Body Security Scanning System**

WHEREAS, there has been a rise in the amount of illegal drugs being introduced into the Rock County Jail by incoming inmates. Correctional Officers are not allowed to complete body cavity searches; and,

WHEREAS, many of the inmates that have prior knowledge of forthcoming incarcerations will utilize body cavities to transport and conceal contraband. Contraband making it through the intake process and into general housing units, puts officers and other detainees at risk of serious injury or death; and,

WHEREAS, in 2022 the Rock County Jail had six fentanyl overdoses, which staff and medical personnel responded to immediately, with successful results, reviving all six individuals: and,

WHEREAS, Tek84 located in Poway, California, is the sole-source vendor for the Tek84 Intercept Whole Body Security Scanning System; and,

WHEREAS, the Sheriff's Office and the Purchasing staff have reviewed the quote and are recommending the immediate purchase of the Tek84 Intercept Whole Body Security Scanning System.

**NOW, THEREFORE BE IT RESOLVED** by the Rock County Board of Supervisors assembled this <u>23rd</u> day of <u>February</u> 2023, that a Purchase Order be issued, to Tek84 of Poway, California totaling the amount of \$159,000 for the purchase of one Body Scanner and one additional year of warranty.

### **Executive Summary**

# Authorizing Purchase Tek84 Intercept Whole Body Security Scanning System

At this time, the Sheriff's Office is looking to initiate the purchase of the Tek84 Intercept Whole Body Security Scanning System, as it was approved in the Sheriff's Office 2023 budget.

Officers do not have the legal authority to search body cavities. Many individuals in our custody have prior knowledge of a forthcoming incarceration and will utilize a body cavity to conceal drugs and/or weapons. Even fresh arrestees will often utilize a body cavity, or intimidate areas, to conceal contraband in an attempt to elude more charges or to bring the contraband in to the jail with them.

The ability to complete an X-ray body scan prior to admission in the Rock County Jail will decrease the amount of drugs and contraband introduced into the secure setting.

In 2022 alone, the Rock County Jail had six Fentanyl overdoses in the general housing units. Fortunately, correctional, and medical staff were able to revive all six individuals through the use of Narcan, CPR and an AED. Narcan, however, does not have the same effect on all drugs like it does with opiates. Drugs and other contraband are often concealed on individuals in intimate areas and/or body cavities making it impossible for officers to detect during a search. Contraband making it through the intake process and into the general housing units puts officers and other detainees at risk.

The Pricing Summary is as follows and is included in the Sheriff's Office 2023 Correctional Facility budget line 21-2200-0000-67125, Capital Assets over \$25,000.00. The initial two-year warranty is included with the purchase. Additional years of warranties can be purchased for \$7,500.00 per year, up to five additional years (seven years total).
