# Authorizing the Human Services Department to Enter Into a Contract with a CLTS Provider

WHEREAS, the Children's Long Term Support (CLTS) program in the Human Services Department (HSD) is a home and community-based service that helps children with disabilities and their families through supports and services to help children grow, live their best lives, and to keep children at home instead of at an institution; and,

WHEREAS, to meet client needs HSD contracts with multiple providers to provide an array of services to children and families that includes Community Integration Services, Daily Living Skills, Respite, Transportation, Mentoring, Personal Supports, Empowerment and Self-Determination Supports, and Family/Unpaid Caregiver Supports and Services; and,

WHEREAS, CLTS is projected to serve over 1,000 participants in 2023; and,

WHEREAS, HSD is requesting to enter into a contract with Full 360 for an amount up to \$250,000, for services and supports through the CLTS program; and,

WHEREAS, services are provided in compliance with the Wisconsin Medicaid Home and Community-Based Services Waiver Manual for the CLTS Waiver Program and based on the clients' specific Individual Support Plans that are completed with the consumers, their care givers, and CLTS case managers; and,

**WHEREAS**, services are authorized by County staff and fully funded by the State through a Third Party Administrator (Wisconsin Physician Service, WPS); and,

WHEREAS, funds are included in the 2023 HSD Adopted budget.

**NOW, THEREFORE, BE IT RESOLVED**, that the Rock County Board of Supervisors duly assembled this <u>23rd</u> day of <u>March</u>, 2023, does authorize the Human Services Department to enter into contract with Full 360 for an amount up to \$250,000.

#### **Executive Summary**

### Authorizing the Human Services Department to Enter into a Contract with a CLTS Provider

The Human Services Department (HSD) is requesting authorization to enter into contract with Full 360 for an amount up to \$250,000. The contract is for services rendered in the Children's Long Term Support (CLTS) program for which expenses are fully funded by the State through a Third Party Administrator.

Children's Long Term Support is program that helps children with disabilities and their families through supports and services that help children grow and live their best lives. It is a home and community based service waiver. It uses a Medicaid waiver to fund services for children with disabilities. A waiver lets states use Medicaid to fund additional non-medical services and supports not normally offered. The CLTS Program aims to keep children at home instead of at an institution.

In 2023, CLTS is expected to serve over 1,000 participants.

Services are authorized by County staff and funded by the State through a Third Party Administrator (Wisconsin Physicians Service, WPS). Service rates are either set by the State, when applicable, or the provider's Usual and Customary Rate.

Full 360 provides Community Integration Services, Daily Living Skills, Respite, Transportation, Mentoring, Personal Supports, Empowerment and Self-Determination Supports, and Family/Unpaid Caregiver Supports and Services to Rock County Clients.
