## Approve Airport Fuel Tank Removal and Installation Bid

WHEREAS, Rock County owns and operates an airport known as the Southern Wisconsin Regional Airport; and,

WHEREAS, the Airport maintains and operates an underground, 1980's model, 5,000-gallon, off-road, diesel fuel storage tank and uses the diesel fuel to operate a wide variety of airport vehicles and tractors; and,

WHEREAS, the existing fuel storage tank had exceeded its life expectancy and proactive replacement was recommended during its last inspection before any leakage occurred, creating an environmental concern; and,

WHEREAS, a project was distributed for public bidding to remove the existing tank and fuel system and install a new Aboveground Storage Tank (AST) system located in close proximity to the Airport Maintenance building. The AST system will include (1) 5,000-gallon off-road diesel tank and (1) 550-gallon unleaded tank, installed on top of a newly constructed concrete pad with safety bollards; and,

WHEREAS, the addition of the unleaded storage tank will eliminate the need to purchase unleaded gas for the remainder of the Airport vehicles and equipment at any off-site gas station.

**NOW, THEREFORE, BE IT RESOLVED** that the Rock County Board of Supervisors duly assembled this <u>23rd</u> day of <u>March</u> 2023, does hereby approve the bid of METCO for \$131,240.
