Authorizing Reclassification of Three (3) 0.4 FTE Child Support Clerical Workers to One (1) 1.0 FTE Child Support Clerk Typist III

WHEREAS, Child Support Services has three (3) current vacancies for a 0.4 FTE Child Support Clerical Worker; and,

WHEREAS, Child Support Services is requesting that the three (3) 0.4 FTE Child Support Clerical Workers be reclassified to one (1) 1.0 FTE Child Support Clerk Typist III; and,

WHEREAS, the 0.4 FTE Child Support Clerical Worker is in Range 14 of the AFSCME Local 2489 Pay Grid and the Child Support Clerk Typist III position is in Range 11 of the AFSCME Local 2489 Pay Grid; and,

WHEREAS, Child Support Services' 2023 budget includes salaries and benefits in the amount of \$64,945 for the three (3) Child Support Clerical Workers and a Child Support Clerk Typist III annual salary and benefits is budgeted at \$58,335, resulting in no increase to the 2023 budget for Child Support Services; and,

WHEREAS, the purpose of this reclassification is to create a more desirable position for recruitment purposes, as the department has struggled to recruit and retain these part-time positions over the last several years.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this <u>27th</u> day of <u>April</u>, 2023, does hereby approve the reclassification of three (3) 0.4 FTE Child Support Clerical Worker positions to one (1) 1.0 FTE Child Support Clerk Typist III position in the Child Support Services 2023 budget.
