**Amending the 2023 Human Services Department Budget to Accept Adult Protective Services ARPA Funding**

**WHEREAS**, the Wisconsin Department of Health Services (DHS) has awarded \$41,838 in Adult Protective Services (APS) – American Rescue Plan Act (ARPA) funding to Rock County; and,

**WHEREAS**, over the last several years, Adult Protective Services has experienced a dramatic increase in the complexity and severity of cases of abuse, neglect, self-neglect, and financial exploitation; and,

**WHEREAS**, these funds will assist in providing goods and services needed to keep clients safe from further exploitation, abuse, and neglect; and,

**WHEREAS**, examples of goods and services that may be purchased using these funds include: in-home supports (including personal care supports), medications, clothing, home cleaning services, groceries, home delivered meals, transportation, respite, and emergency housing; and,

**WHEREAS**, this funding has no match requirement; and,

**WHEREAS**, the funding period is October 1, 2022 through September 30, 2024.

**NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board of Supervisors duly assembled this 25th day of May, 2023, does hereby authorize the acceptance of the Adult Protective Services – ARPA funding.

**BE IT FURTHER RESOLVED**, that the Human Services Department budget for 2023 be amended as follows:
