Approval for Amending the 2023 Facilities Management Budget for the Fairgrounds Grandstand Roof Replacement

WHEREAS, the resolution to contract for the Fairgrounds Grandstand roof replacement in 2023 has already been approved by the General Services Committee as well as the County Board in the amount of \$121,870, plus \$12,187 in contingency money; and

WHEREAS, the 2023 budget allocated sales tax in the amount of \$180,000 for funding this roof replacement; and

WHEREAS, the General Services Committee is requesting a 2023 Facilities Management budget amendment applying American Rescue Plan Act (ARPA) funding to fund this roof replacement; and

WHEREAS, the low bidder for the roof replacement does have a Unique Entity ID number which is required to do projects that are funded with Federal dollars; and

WHEREAS, the cost for design work for the roof replacement was \$5,000; and

WHEREAS, the total cost for the roof replacement is \$139,057.

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this <u>22nd</u> day of <u>June</u>, 2023 does hereby approve that the Facilities Management 2023 budget be amended as follows:
