Reserving Broadband Bonding Commission Guarantee Payments for Broadband Project and Amending the 2023 Budget

WHEREAS, the Rock County Broadband Expansion Project contains various funding sources including Fond du Lac County bonding for expanding broadband service in Rock County

WHEREAS, Resolution #2022-51 requires Bug Tussel Wireless to pay Rock County a Guarantee fee for processing the Fond du Lac County bond funding and totals \$863,645 over the life the 30 year bonds with the County receiving the 1st payment in 2022 in the amount of \$21,800; and 2023 payments in the amount of \$52,804.

WHEREAS, Rock County will be incurring additional expenses for broadband expansion activities, including applying for state/federal grants that will require local cash match;

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this <u>22nd</u> day of <u>June</u>, 2023, sets aside the annual Fond du Lac County Bond Guarantee Fee as outlined in the agreement between the County and Bug Tussel Wireless, LLC and use the funds for broadband expansion activities, including local cash match for state/federal grants.
