# **Budget Amendment East Hangar Development Construction Project**

**WHEREAS**, the Southern Wisconsin Regional Airport is considered a Large, General Aviation Public-Use Airport in Wisconsin that provides a safe flying environment to its customers. The Airport is owned and operated by Rock County; and,

**WHEREAS**, the Airport Director initiated a plan in 2020 to develop 13 acres of Airport land for more land-lease opportunity from private and commercial hangar owners. This was referenced as the "east hangar area development project" in the Capital Improvement Plan, and the County Board approved \$75,000 in the 2023 budget as a local share for this project; and,

WHEREAS, the Airport Director has been working with federal and state officials to maximize possible grant money and minimize local share expenses. The state acts as an agent for General Aviation Airports to acquire BIL, federal apportionment, and block grant entitlement money. The BIL grant money doesn't get awarded until a project is approved and often has lag time even after being awarded; and,

**WHEREAS**, the final project bid closed June 8, 2023 at \$2.38 million dollars to Rock Road not including engineering and state administrative costs. The local share is estimated to be \$220,000 with the balance being covered by federal and state funds; and,

**WHEREAS**, the Airport currently has \$197,579 in the department's Capital Fund Balance not obligated for other Airport projects; and.

**NOW, THEREFORE, BE IT RESOLVED** that the Rock County Board of Supervisors assembled on this <u>13th</u> day of <u>July</u>, 2023, does hereby approve the budget amendment and obligation of funds in the amount of \$145,000 using the Airport Department Capital Fund Balance to be used for the East Hangar Development Project.

**BE IT FURTHER RESOLVED** the Rock County Board of Supervisors approves the letter by the Wisconsin Bureau of Aeronautics requesting Rock County to acknowledge \$1.65 million of the East Hangar Development Project will come from BIL and state entitlement funds yet to be officially approved but anticipated to be approved within weeks of construction starting.
