## Awarding the Contract for the Installation of Health Department HVAC Controls Upgrade

WHEREAS, the budget included \$100,000 for replacing the Health Department HVAC controls; and

**WHEREAS**, the controls are still the old pneumatic system that we struggle getting technicians in for repair due to being outdated controls; and

**WHEREAS**, Angus Young and Associates provided engineering services and specifications in the amount of \$24,000 so this work could be bid out; and

WHEREAS, bids were solicited, with six (6) contractors submitting bids; and

**WHEREAS**, the lowest, most responsive, and responsible bidder was Sun Mechanical located in Janesville, WI, at the cost of \$125,000; and

WHEREAS, the project is coming in over budget in the amount \$49,000; and

**WHEREAS**, funds are being transferred from the Youth Services Center Capital account due to the boiler replacement project which came in under budget by \$54,000.

**NOW, THEREFORE, BE IT RESOLVED,** that the Rock County Board of Supervisors duly assembled this 10<sup>th</sup> day of August, 2023 does hereby approve and authorize awarding a contract in the amount of \$125,000 to Sun Mechanical of Janesville, WI for the Health Department HVAC controls upgrade.



### **EXECUTIVE SUMMARY**

Awarding the Contract for the Installation of Health Department HVAC Controls upgrade

This Resolution is approving contracting with the lowest, most responsive, and responsible bidder, Sun Mechanical, of Janesville WI, in the amount of \$125,000 for replacement of the Health Department HVAC controls. The original approved budget for the replacement of the controls were set at \$100,000.

The engineering cost was \$24,000 and the low bid was for \$125,000 which put us \$49,000 over budget.

The Youth Services Center boiler project came in under budget by \$54,000. Funds are being transferred to cover this additional \$49,000 cost.
