**Narcotics Search Warrants Served in the City of Beloit**

On September 28, 2023, the Rock County Sheriff's Office Special Investigations Unit concluded a nearly year-long investigation into the distribution of cocaine in the Rock County area. The investigation was conducted with the assistance of the United States Drug Enforcement Administration, Wisconsin Division of Criminal Investigations, Beloit Police Department, and the Janesville Police Department.

A total of six residential search warrants were executed in the city of Beloit. As a result of the search warrants three firearms and US Currency were seized. The Walworth County Sheriff's Office, Town of Beloit Police Department, Town of Beloit Fire Department, City of Beloit Fire Department, MD1, and the above aforementioned agencies all assisted with the search warrant executions.
