Awarding Contract for Catering Services for Rock County Aging Unit Nutrition Program

WHEREAS, Rock County provides approximately 65,500 meals annually to older adults through the Nutrition Program's five congregate meal sites and the home delivered meal service; and,

WHEREAS, Rock County contracts for the preparation and delivery of congregate and home delivered meals provided through the Elderly Nutrition Program; and,

WHEREAS, the Rock County Purchasing Division did advertise and solicit Proposals from food service providers for catering services for 2024 through 2026 with options for renewal in 2027 and 2028; and,

WHEREAS, Purchasing and Aging Unit staff reviewed the proposal received from Kandu Catering & Rentals of Janesville, Wisconsin and determined it was a responsive and responsible proposal which meets the requirements of the County; and,

WHEREAS, Kandu Catering & Rentals set forth in the Request for Proposal #2023-22 the rates of \$7.38 per meal for 2024, \$7.68 per meal for 2025 and \$8.00 per meal for 2026, and \$8.93 per special meal for 2024, 2025, and 2026; and,

WHEREAS, the total 2024 estimated cost of these services is \$491,612; and,

WHEREAS, sufficient funds are included in the 2024 HSD Adopted Budget.

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this <u>14th</u> day of <u>December</u>, 2023, that a contract for the Nutrition Program Food Preparation and Delivery be awarded to Kandu Catering & Rentals of Janesville, Wisconsin under the terms and conditions set forth in Request for Proposal #2023-22 The contract also allows for two one-year contract extensions (2027 & 2028) at a cost not to exceed the CPI.

FISCAL NOTE:

Sufficient funds were included in the 2024 budget for this contract. The contract is being funded with federal grant revenue, contributions and tax levy.
