# Authorizing Acceptance of the 2024 Anti-Methamphetamine Task Force Grant and Amending the 2024 Sheriff's Office Budget

WHEREAS, the Wisconsin Department of Justice, Division of Criminal Investigation (DCI), has been selected as a recipient of the 2024 COPS Office Anti-Methamphetamine Task Force; and,

WHEREAS, the Rock County Sheriff's Office has been invited to be part of the Anti-Methamphetamine Task Force; and,

WHEREAS, the purpose of the grant is to allocate additional resources for local, multi-jurisdictional, drug task forces; and,

WHEREAS, the Rock County Sheriff's Office is eligible to receive \$5,000 for participating in this grant; and,

WHEREAS, grant funds will be used for overtime wages only; and,

WHEREAS, the grant does not require a local match; and,

WHEREAS, the grant runs from January 1, 2024 through December 31, 2024.

**NOW, THEREFORE BE IT RESOLVED** by the Rock County Board of Supervisors assembled this <u>22nd</u> day of February <u>2024</u>, that the Rock County Sheriff is authorized to accept funds under the Anti-Methamphetamine Task Force Grant.

**BE IT FURTHER RESOLVED,** that the 2024 budget be amended as follows:
