Authorizing Acceptance of Rock County Equity Project Grant Funds

WHEREAS, Alia will award grant funds to the Rock County Human Services Department to provide real-time support to families and kinship providers in order to prevent out-of-home placement and preserve family connections; and,

WHEREAS, this funding allows leaders to be creative and responsive to meet the needs of families; and.

WHEREAS, the goal of this funding is to demonstrate the effectiveness of real-time supports that can prevent out-of-home placements and make a difference for child outcomes; and,

WHEREAS, this resolution will give Rock County permission to enter into an agreement in the amount of \$70,000; and,

WHEREAS, this grant, beginning January 1, 2024 for a three year period, will be primarily used to provide tangible support for families impacted by Rock County Human Services Department Child Protective Services Unit in an effort to preserve family connections; and,

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this 14th day of March, 2024, does hereby accept the grant funds in the amount of \$70,000.
